### **CONGRESSMAN DONALD M. PAYNE, JR. (1958 - 2024)**

- Congressman Donald Payne, Jr. passed away on Wednesday, April 24th, after serving as the U.S. Representative for New Jersey's 10th Congressional District since 2012.
- Governor Murphy signed Executive Order No. 357, ordering the flag of the United States of America
  and the flag of New Jersey to fly at half-staff from Wednesday, May 1, 2024, through Thursday,
  May 2, 2024, in recognition and mourning of the dedicated legislator and public servant,
  Representative Donald M. Payne, Jr.
- Congressman Payne, Jr. will lie in state at the Essex County Historic Court House in Newark, New Jersey on Wednesday, May 1st. A public viewing will take place from noon until midnight.
- A funeral Mass will take place at Cathedral Basilica of the Sacred Heart in Newark, New Jersey at 10 AM on Thursday, May 2nd.



### **GOVERNOR MURPHY SIGNS MONUMENTAL AFFORDABLE HOUSING LEGISLATION**



- Governor Murphy signed historic legislation to make housing more affordable and more accessible for working families all across New Jersey.
- Here's a snapshot of the enacted bills resulting from the work of legislators, advocates -- like Fair Share Housing Center, and stakeholders.
- A-4/5-50 Abolishes the Council on Affordable Housing and establishes a process for municipalities to determine their own present and prospective fair share affordable housing obligations based on the formulas provided in the bill.
   Requires calculations to be submitted by November 15, 2024.
   Appropriates \$16 million to the project. (P.L. 2024, c.2.)
- A-3337/S-2312 Allows projects supported by the State or municipal affordable housing trust fund to contribute to municipal services by making "payments in lieu of taxation" (PILOT). (P.L.2024, c.6.

- A-2267/S-1415 Requires the New Jersey Housing Mortgage and Finance Agency (HMFA) to establish a pilot program to support insurance premiums for eligible affordable housing projects constructed by forprofit affordable housing developers ({P.L.2024, c.4).
- A-2296/5-2309 Permits a municipality to authorize the municipal clerk to submit certain written statements concerning affordable housing units, limits certain HMFA powers. (P.L.2024, c.5.)
- A-1495/S-1484 Exempts receipts from sales made to contractors or repairpersons of materials, supplies, or services related to the construction of 100%-affordable housing projects in order to help reduce the costs for constructing such projects. (P.L.2024, c.3).
- A-3365/S-1422 Allows allows taxpayers to accelerate the depreciation of eligible property expenditures in connection with construction of new affordable housing developments in order to realize cost saving (P.L. 2024, c.1.)

### INAUGURAL AI SUMMIT

On Thursday, April 11th, the Murphy Administration and Princeton University hosted the inaugural Artificial Intelligence (AI) Summit. The AI Summit convened subject matter experts, industry leaders, policy makers, researchers, and entrepreneurs from across the country and the globe. Princeton Alum Brad Smith, Vice-Chair and President of Microsoft Corporation, gave the keynote address, observing that New Jersey was poised to lead the next phase of AI innovation guided by a moral compass.

The Al Summit continued collaboration that began in the fall of 2023 when the Murphy Administration and Princeton University launched the New Jersey Al Hub. The New Jersey Economic Development Authority recently announced a <u>Request for Information (RFI)</u> to gather best practices and operational insights that will help to advance the work of the NJ Al Hub. Responses are due by May 31st.

# NEW JERSEY MATERNAL AND INFANT HEALTH INNOVATION AUTHORITY

On Wednesday, March 27th, Governor Murphy and First Lady Tammy Murphy attended the inaugural board meeting of the New Jersey Maternal and Infant Health Innovation Authority (NJMIHA) which is tasked with overseeing the New Jersey Maternal and Infant Health Innovation Center based in Trenton, continuing the work of Nurture NJ to reduce the maternal and infant mortality epidemic in New Jersey, and ensuring equitable care among women and children of all races and ethnicities.

The Authority is governed by a 15-member Board which appointed Lisa Asare as the President and Chief Executive Officer of NJMIHA.

Lisa Asare has been in public service for the past two decades, holding various positions within the Department of Health and the Department of Human Services. Asare was most recently the Deputy Commissioner of the Department of Human Services, overseeing the Division of Mental Health and Addiction Services and leading the departments' work with the Nurture NJ initiative.



### **NEW JERSEY-INDIA COMMISSION EXECUTIVE DIRECTOR**

On Thursday, April 18th, Governor Murphy and Lieutenant Governor Tahesha Way announced Rajpal (Raj) Bath as the Inaugural Executive Director of the New Jersey-India Commission. Prior to this role, Raj Bath was a Senior Aide to Governor Murphy. Governor Murphy established the Commission in February 2024 through Executive Order No. 354 to advance bilateral trade, investment, and economic development between New Jersey and India. The Commission also aims to promote cultural and educational exchanges between the two countries to create a partnership that will lead to sustainable, long-term economic growth.

"Leading the way to a clean energy future in New Jersey" - Governor Murphy

- On Earth Day, President Biden announced that New Jersey will receive \$156 million in solar power federal grants.
- On Friday, April 26th Governor Murphy visited Eagles I & II community solar projects in Bayville, announcing major investments in clean energy.

New Jersey weathered two significant events in April:

- April 5th: The New Jersey Earthquake registered 4.8 in magnitude.
  - The largest in the region since 1973, with at least 51 aftershocks in the days and weeks that followed
  - Scientists suspect that the earthquake likely originated in the area of the Ramapo fault zone in the Newark basin.
- April 8: Total solar eclipse
  - The next one can be viewed in Spain in 2026.
