

NEW JERSEY WIC VENDOR MINIMUM STOCK REQUIREMENTS

The following table outlines the **minimum stock requirements** for NJ WIC Authorized Vendors.

Note: Exceptions to the Vendor Selection Criteria may be granted if the State agency determines that a vendor is needed for participant's access in accordance with the State agency's policies.

***Minimum Stock Requirements for Baby Foods: One 2-pack counts as 2-4oz. individual containers.**

Example: (16) 4oz. Baby Fruit = (8) 2-4oz. individual containers

(32) 4oz. Baby Vegetable = (16) 2-4oz. individual containers

Baby Foods – Organic Allowed

Canned Beans – Organic Allowed

**Canned Fruits & Vegetables CVB: Pastes, purees, whole, crushed, stewed & diced tomatoes, Green peas and lima beans
Any size (single serving fruit cup packs are allowed)**
