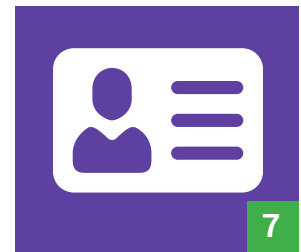

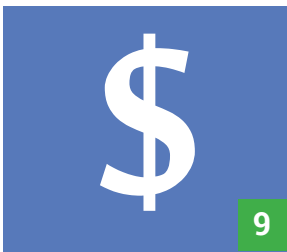

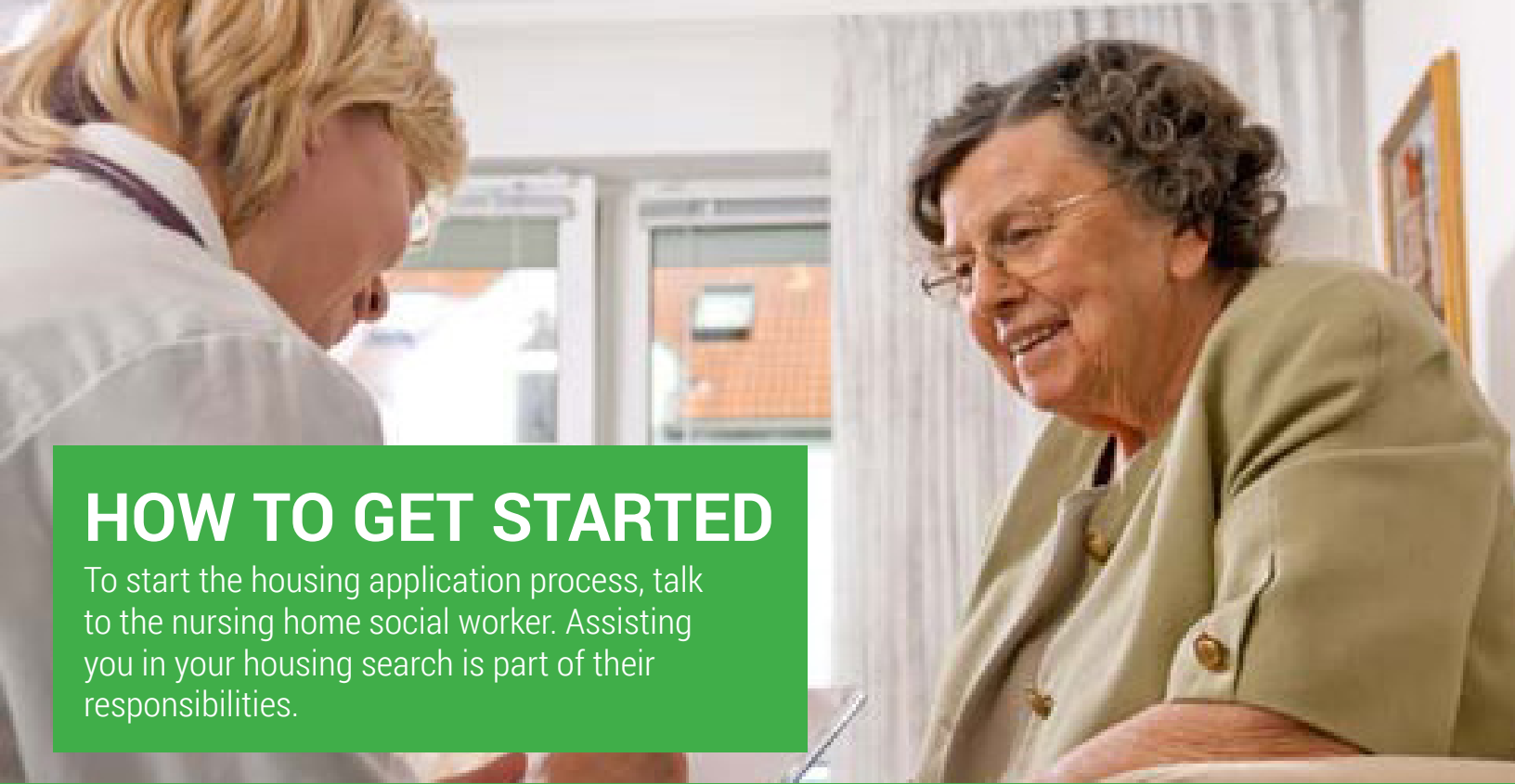

HOW TO GET STARTED

To start the housing application process, talk to the nursing home social worker. Assisting you in your housing search is part of their responsibilities.

WHAT TO EXPECT

- Moving out of the nursing home takes time and will not be immediate.
- Your commitment and hard work is necessary.
- People can help you (facility social worker, your MCO* care manager, the state nurse, the housing specialist, your family and friends).
- Many affordable and accessible housing complexes have waiting lists.
- Personal identification documents are needed to complete housing applications.
- The housing application process may require a credit and background check.

It is important that you disclose all issues (credit, criminal history, unpaid utilities, etc.) that may slow the lease-up process so that they may be dealt with up front before becoming an issue with your move.

ASK ABOUT IN-HOME SERVICES

If eligible, Community Transition Services may be available to help you move into your new home. Services could include:

- Payment of security deposit, utility deposits, furniture, linens, pots and pans, groceries, etc.

Other in-home services could include:

- Case management, personal care attendant, special and durable medical equipment, adult day care, transportation, home-delivered meals, personal emergency response system, etc.

TYPES OF HOUSING

AFFORDABLE HOUSING

- In New Jersey, this means you generally should contribute no more than 30% - 40% of your income towards your housing costs.
- You can find affordable housing through many different sources – your local Public Housing Authority, online through websites such as Craigslist, through a private realtor, or by using free housing resources specific to low-income people (see p. 10).

SUBSIDIZED HOUSING

If eligible, a portion of the rent is paid by a state or federal agency through a local housing provider such as a public housing authority. There are two types:

- Tenant-based rental assistance
 - Example: Section 8 Voucher, NED2 Voucher
 - Often have waiting lists
- Project-based rental assistance
 - To receive the assistance you must live in a unit at a specific building to which the subsidy is attached.
 - Often have waiting lists
- To apply for subsidized housing, contact the Department of Community Affairs (DCA Regional Office List on p.10) or your local Public Housing Authority (pp. 11-16).
- After you send your paperwork to the DCA regional office and they find you eligible, they will interview you in a "Briefing." After this, the next step is "Housing Search," in which you will be expected to actively look for housing.

ACCESSIBLE HOUSING



Housing units that have features to help meet the needs of individuals with mobility, hearing and vision impairments are considered accessible.

Types of accessible features that you may need, include:

- wide doorways
- space for wheelchairs
- lower countertops
- lever and loop type handles as hardware
- seats at bathing fixtures
- grab bars in bathrooms
- knee spaces under sinks and counters
- audible and visual signals
- switches and controls in easily reached locations
- entrances free of steps and stairs
- an accessible route through the house

WHAT IF I DO NOT HAVE THE DOCUMENTS NEEDED TO APPLY?

- Ask your family, friends or nursing home social worker to help you.
- Social security cards can be obtained from the Social Security Administration.
- Photo IDs can be obtained from your local NJ Motor Vehicle Commission office and from some NJ counties.
- Birth certificates can be obtained from the NJ Department of Health Office of Vital Statistics.

BIRTH CERTIFICATE

YOUR INCOME

- When you are in the nursing home, you are likely either not receiving your income (ex: social security payments or pension) or you are receiving it and paying it over to the nursing home.
- When you move out, you will need to access your monthly income to pay your living expenses in the community – including rent, utilities, food, etc.
- It is important to discuss this with the facility social worker and/or business office in advance so that you can have access to your income when you leave.
- If you are receiving SSI or SSDI, you will also need to get proof of what your income will be once you move out of the facility. This can be complicated, so you will want to work with your social worker to do this early.

BACKGROUND & CREDIT CHECK

Landlords may check your credit.

Landlords may check your background.

Housing may be denied for the following reasons:

- Applicant has been convicted of manufacturing methamphetamines.*
- Applicant is a registered sex offender.*
- Applicant has a history of illegal use of a controlled substance.
- Applicant has a history of violent criminal activity.
- Other circumstances may also be considered by housing providers, including poor credit.

*If you are applying for a housing subsidy through the Department of Community Affairs/NJ Public Housing Authority, you will be denied for this reason.

Requesting Reasonable Accommodation Through NJ DCA

If you have a disability, it is a reasonable accommodation to ask a worker from the regional DCA office to interview you at the nursing home.

Other reasonable accommodations throughout the DCA application process may include:

- receiving applications in large print, braille, etc.;
- getting assistance in completing applications; and
- being allowed to send someone else to pick up and drop off your application.

- Service is available during the same times as the regularly scheduled local fixed bus route.
- A transit fare is charged to customers.
- It is a "shared-ride" system.
- It is a "curb to curb"
