2017 FARM CREDIT EAST FFA LEADERSHIP GRANT

What is the Farm Credit East FFA Leadership Grant?

Farm Credit East, a farmer-owned lending cooperative and FFA supporter, is providing funds to New Jersey FFA chapters to provide FFA members and local chapters leadership opportunities. Up to five (5) grants of \$1000 will be awarded to eligible New Jersey FFA chapters.

What can this grant be used for?

This Leadership Grant is designed to provide leadership opportunities for active FFA members. It is not designed to be used for direct adult expenses. This grant award may be used in the following ways:

- To pay event fees for the Leadership Experience and Development Conference hosted by the New Jersey FFA Association
- To pay for transportation to and from Leadership Experience and Development
- To pay for hotel room fees for Leadership Experience and Development
- To pay for additional student expenses associated with attending Leadership Experience and Development (must explain)

Eligibility:

Chapters that are in good standing with the New Jersey FFA Association and that promote and strengthen the FFA organization and the agriculture industry in the following ways:

- · Development of young and beginning agriculturalists
- Encourage leadership and teamwork
- Develop a greater understanding of agriculture and the FFA
- Promote interest in the agriculture industry

Application Process & Requirements:

The Farm Credit East FFA Leadership Grant Program awards grants upon the review of an application and narrative. Accumulated points on applications will determine recipients for grant awards. Up to three (3) pages of supporting materials may also be included.

- Applicants must submit a complete application as one PDF file. All requested signatures, as outlined in this application, must be provided.
- Applications must be receive via email (<u>ag.ed.registration@ag.state.nj.us</u>) at 4 pm on Monday, August 1, 2017.
- No facsimiles or originals will be accepted.
- Additional documentation will not be accepted after the grant is received.
- Final Report materials, not to exceed two (2) pages, must be submitted by November 15.
