# BPU and DCA to host 2<sup>nd</sup> Energy Efficiency (EE) and Renewable Energy (RE) Training for Local Governments

State Programs, Financial Incentives and Legislative Initiatives to be Reviewed

(NEWARK, NJ) – More than 200 local government officials are expected to gather on Wednesday, **May 27, 2009,** at Rowan University to learn about the state's programs and financial incentives for renewable energy and energy efficiency work at the local level. A second meeting has been scheduled for officials who could not attend the April 15<sup>th</sup> meeting in New Brunswick. The program is jointly sponsored by the New Jersey Board of Public Utilities (BPU) and Department of Community Affairs (DCA). Officials representing municipalities, counties and local authorities will be provided briefings on a number of programs designed to help local governments save money and protect the environment by achieving the goals of Governor Corzine's Energy Master Plan. Among the agenda items is the first public "roll-out" of the new Energy Savings Improvement Program (ESIP), information about the state's new Solar Power Purchase Agreements, the BPU Community Partners and other BPU energy policy initiatives.

Renewable Energy (RE) and Energy Efficiency (EE) initiatives are both a state priority and a priority of the federal government's economic stimulus spending. Investments in these initiatives can lower energy costs, which directly affects local property taxes. Governor Corzine's Energy Master Plan has identified RE/EE as major priorities for the state in the coming years. It calls for achieving 30% of the State's electricity needs from renewable sources by 2020. It also calls for EE initiatives to save electricity equivalent to the amount of power needed to run 2.2 million homes for a year (20,000 GWh) and to save heating energy equivalent to the amount of energy needed to warm 1.1 million homes in one year (110 trillion BTUs).
