Energy Master Plan Public Hearing Dates

Pursuant to the Open Public Meetings Act, N.J.S.A. 10:4-6 et seq., the New Jersey Board of Public Utilities (Board) hereby gives notice of scheduled Public Hearings to discuss the 2011 Draft Energy Master Plan Work Group Recommendations being attended by the Board's Commissioners. The Public Hearing dates will be October 21, November 1, November 7, and November 10, 2011, as listed below.

Governor Christie tasked the Board with revisiting the 2008 Energy Master Plan in light of current economic conditions to ensure a balance between increasing challenges in meeting current and future energy demands in New Jersey. To accomplish its goal of ensuring that New Jersey continues to have reliable energy at reasonable rates, the Board released a draft revision to the 2008 Energy Master Plan via the Board of Public Utilities' website and EMP listserv.

In conjunction, the Board also established four working groups comprised of subject matter experts from various industries, academia and membership organizations in order to provide the Board with specific recommendations on the following topics found in the 2011 Draft Energy Master Plan:

Clean Energy Funding Alternatively Fueled Vehicles Innovative Technologies Biomass

The recommendations from these four working groups, which will be posted on the EMP website (http://nj.gov/emp/index.shtml), will be evaluated and considered by the Board as the draft EMP is finalized. The Board is committed to providing information to the public as well and to making sure that the public also has the opportunity to provide input during this process.
