EXECUTIVE SESSION

After appropriate motion, the following matter, which involved pending litigation attorney-client privilege, and/or contract exceptions to the Open Public Meetings Act was discussed in Executive Session.

2. ENERGY

G. Docket No. ER17040335 – In the Matter of the Provision of Basic Generation Service for the Period Beginning June 1, 2018 – Rockland Electric Company's Request for Proposal – RFP Results.

Discussion: Stacy Peterson of the Energy Division presented this matter. By Order dated November 21, 2017, the Board approved the proposal by Rockland Electric Company (RECO) to conduct a procurement process where RECO would enter into a bilateral agreement or agreements to hedge the cost of energy purchases through the New York Independent System Operator to satisfy the basic generation service energy needs for residential and small commercial customers in the Company's central and western divisions. In addition, the Board also approved Rockland's proposal to address the capacity needs of these customers through purchasing it in the New York Independent system operators monthly capacity market.

The independent analysis conducted by Bates White indicated that the RFP proceeded without meaningful interruption, according to the Board-approved Auction rules, and in an acceptably fair and transparent manner. Bates White recommended the Board certify the results and the final results of the RFP. It should be noted that these results are treated as confidential information pending Board approval of the results of the BGS Auctions to be conducted beginning on February 2, 2018, and will not be released until after the BGS-RSCP and BGS-CIEP auction results are considered by the Board.

Therefore, Bates White and Board Staff recommended that the Board certify the results.

After appropriate motion, the Board reconvened to Open Session.

There being no further business before the Board, the meeting was adjourned.
