**BY THE BOARD:**

On September 5, 2008, pursuant to N.J.S.A. 48:2-21 and N.J.A.C. 14:1-5.12, United Water New Jersey Inc. (Company or Petitioner), a public utility of the State of New Jersey subject to the jurisdiction of the Board of Public Utilities (Board), filed a petition seeking to increase and revise its rates and charges for water service amounting to a requested increase in revenues of approximately \$47,213,481 or approximately 31.5%. The Company proposed making the rates effective on October 10, 2008.

On September 29, 2008, the matter was transmitted to the Office of Administrative Law for hearing. At its regularly scheduled and noticed agenda meeting on October 3, 2008, the Board voted to suspend the revised rates of Petitioner until February 10, 2009, pending a hearing and determination on the justness and reasonableness of the Company's proposed rates.

In light of the fact that this proceeding is pending before the Office of Administrative Law and not likely to be completed by February 10, 2009, the Board HEREBY ORDERS, pursuant to N.J.S.A. 48:2-21(d), that the proposed revisions in rates be and are HEREBY FURTHER


SUSPENDED until June 10, 2009, unless the Board prior to that date makes a determination disposing of the petition.




