BY THE BOARD:

This Order memorializes action taken by the Board of Public Utilities (Board) at its October 3, 2007 Agenda Meeting.

The Board of Public Utilities' Customer On-Site Renewable Energy (CORE) program offers prescribed financial incentives to New Jersey ratepayers to encourage the installation of Class I renewable energy technologies. Eligible applicants may receive rebates for a portion of the cost of installing solar, wind or sustainable biomass at their site.

The Staff of the Office of Clean Energy (OCE) has reviewed the application of Trent Center West, Inc. for a monetary rebate in the amount of \$130,250 under the CORE Program. The CORE rebate application requests a rebate toward installation of a solar electric system at 485 Greenwood Avenue, Trenton, New Jersey. The number assigned to this application by OCE is MM05524. The docket number for this matter is EO07090680. OCE finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

The Staff of the Office of Clean Energy has reviewed the application of Conifer-LaChase Construction, LLC for a monetary rebate in the amount of \$141,150 under the CORE Program. The CORE rebate application requests a rebate toward installation of a solar electric system at 901 Norcross Road, Lindenwold, New Jersey. The number assigned to this application by OCE is MM05528. The docket number for this matter is EO07090681. OCE finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

The Staff of the Office of Clean Energy has reviewed the application of Kent Street Senior Citizen Housing for a monetary rebate in the amount of \$270,100 under the CORE Program. The CORE rebate application requests a rebate toward installation of a solar electric system at 11 Kent Avenue, Pennsville, New Jersey. The number assigned to this application by OCE is MM05526. The Staff of the Office of Clean Energy has reviewed the application of KOR Company for a monetary rebate in the amount of \$2,231,608 under the CORE Program. The CORE rebate application requests a rebate toward installation of a solar electric system at Bordentown-Hedding Road, Bordentown, New Jersey. The number assigned to this application by OCE is BPU-2360. The docket number for this matter is EO07090683. OCE finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

The Staff of the Office of Clean Energy has reviewed the application of FAVS Corporation for a monetary rebate in the amount of \$108,798 under the CORE Program. The CORE rebate application requests a rebate toward installation of a solar electric system at 331 Husted Station, Palatine, New Jersey. The number assigned to this application by OCE is BPU-2428. The docket number for this matter is EO07090684. OCE finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.

The Staff of the Office of Clean Energy has reviewed the application of Donald Gulbrandsen for a monetary rebate in the amount of \$205,761.60 under the CORE Program. The CORE rebate application requests a rebate toward installation of a solar electric system at 40 Holland Road, Bedminster, New Jersey. The number assigned to this application by OCE is BPU-2508. The docket number for this matter is EO07090686. OCE finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.<sup>1</sup>

The Staff of the Office of Clean Energy has reviewed the application of the Jersey City Public School District. for a monetary rebate in the amount of \$1,100,700 under the CORE Program. The CORE rebate application requests a rebate toward installation of a solar electric system at Public School No. 28, 167 Hancock Avenue, Jersey City, New Jersey. The number assigned to this application by OCE is MM05277. The docket number for this matter is EO07090688. OCE finds that said application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.






