
On November 1, 2007, S. B. Water Company (Company or Petitioner), a public utility of the State of New Jersey subject to the jurisdiction of the Board of Public Utilities (Board), filed a petition pursuant to N.J.S.A. 48:2-21 and N.J.A.C. 14:1-5.12 seeking to increase and revise its rates and charges for water service amounting to \$30,721 or approximately 20.54%. The Company proposed to make the rates effective on and after December 7, 2007.

The matter was transmitted to the Office of Administrative Law for hearing. On November 28, 2007, the Board suspended the proposed increase in rates until April 7, 2008, pending a determination on the hearing on the justness and reasonableness of Petitioner's proposed rates.

In light of the fact that this proceeding is pending before the Office of Administrative Law, the Board HEREBY ORDERS, pursuant to N.J.S.A. 48:2-21, that the proposed revisions in rates be and are HEREBY FURTHER SUSPENDED until August 7, 2008, unless the Board prior to that date makes a determination disposing of the petition.
