By petition filed on February 1, 2006, William Taylor (Petitioner) claimed that he had been over-billed by Jersey Central Power & Light Company (Respondent) due to Respondent's alleged provision of low-voltage to his residence, which Petitioner contends has caused the failure of many appliances. After receipt of Respondent's answer, this matter was transmitted to the Office of Administrative Law for hearing as a contested matter.






