BY THE BOARD:

On January 14, 2008, pursuant to N.J.S.A. 48:2-18, N.J.S.A. 48:2-21 and N.J.S.A. 48: 2-21.1, N.J.A.C. 14:1-5.7 and N.J.A.C. 14:1-5.12, Petitioner, New Jersey American Water Company, Inc., (Petitioner or NJAW) a public utility of the State of New Jersey subject to the jurisdiction of the Board of Public Utilities (Board) and serving approximately 606,500 water customers and 28,400 wastewater customers within certain portions of Atlantic, Burlington, Camden, Cape May, Essex, Gloucester, Hunterdon, Mercer, Middlesex, Monmouth, Morris, Ocean, Passaic, Salem, Somerset, Union and Warren Counties, New Jersey, filed a petition for a revision of its rates for water and wastewater service, amounting to an overall increase of approximately \$124,745,975 or 23.35% in annual revenues. The increase in rates was proposed to become effective on February 14, 2008.

This matter was transmitted to the Office of Administrative Law for hearings on January 15, 2008, and on February 4, 2008, the Board issued an Order suspending NJAW's proposed rate increase until June 14, 2008. This matter is currently before the Office of Administrative Law and hearings are scheduled to begin in September 2008.

In light of the fact that this proceeding is still pending before the Office of Administrative Law, the Board HEREBY ORDERS, pursuant to N.J.S.A. 48:2-21, that the proposed revisions be and are hereby further suspended until October 14, 2008, unless the Board prior to that date makes a determination disposing of the petition.
