BY THE BOARD:

On July 3, 2002, the Board of Public Utilities adopted a stipulation of settlement that authorized the change of control between Atlantic City Electric Company ("ACE"), Conectiv Communications, Inc., and New RC, Inc. The Order set forth a number of requirements, including, for the current purposes, the commitment by ACE to provide \$1 million to a fund available to the New Jersey Department of Education for use as the Commissioner of Education sees fit within the ACE service territory. It is the Board's understanding that ACE provided the funds to the State Treasury, but that the funds have not been fully distributed, and that the 36 months cited in the Order has now passed.

In order to facilitate the purposes of the Stipulation and Board Order, and in light of the continuing need for educational support, the Board HEREBY MODIFIES its prior Order and ORDERS that the funds may be distributed as directed by the New Jersey Department of Education without consideration of the 36 month deadline previously set by the Board.

No other elements of the Board's July 3, 2002 Order are impacted by this decision and modification.






