**BY THE BOARD:**

On August 14, 2009, Atlantic City Electric and Company ("Company"), a public utility of the State of New Jersey subject to the jurisdiction of the Board of Public Utilities ("Board"), filed a petition for approval of an increase in its electric base rates of approximately 4% to be effective for service rendered on and after September 14, 2009, as well as for certain other tariff changes pursuant to N.J.S.A. 48:2-21 and N.J.S.A. 48:2-21.1.


This matter was transmitted to the Office of Administrative Law on September 15, 2009.

By Order dated September 16, 2009, the Board suspended the Company's proposed rates until January 14, 2010. Since this matter will not be completed by January 14, 2010, an Order further suspending the Company's rates until May 14, 2010 is warranted.


