BY THE BOARD:

On March 4, 2016, Stanislav Borukovich ("Petitioner") filed a petition with the Board of Public Utilities ("Board") related to a billing dispute involving July 14, 2015 water charges with Suez New Jersey ("Suez Water" or "Respondent") for water services rendered by Respondent to the Petitioner.

After the filing of Respondent's answer on March 31, 2016, the Board transmitted this matter to the Office of Administrative Law ("OAL") for hearing and initial disposition as a contested case pursuant to N.J.S.A. 52:14B-1 et seq. and N.J.S.A. 52:14F-1 et seq. This matter was assigned to Administrative Law Judge ("ALJ") Richard McGill.

The parties subsequently voluntarily agreed to resolve the matter and entered into a signed Stipulation of Settlement ("Stipulation") that was submitted to the ALJ. By Initial Decision issued on September 13, 2016, and submitted to the Board on September 15, 2016, to which the Stipulation was attached and made part thereof, ALJ McGill found that the Stipulation was voluntary, that its terms fully disposed of all issues in controversy and that it satisfied the requirements of N.J.A.C. 1:1-19.1.

Pursuant to the terms of the Stipulation, and in order to fully resolve this matter, Petitioner agreed to pay Respondent the amount of \$775.00, with respect to the July 14, 2015 water charges. Petitioner agreed that the petition in the above matter be withdrawn with prejudice. After review of the Initial Decision and the Stipulation, the Board HEREBY FINDS that the parties have voluntarily agreed to the settlement as evidenced by their signatures and that, by

the terms of the Stipulation, they have fully resolved all outstanding contested issues in this matter. Accordingly, the Board HEREBY ADOPTS the Initial Decision and the Stipulation executed by the parties in their entirety as if fully set forth herein.



BEFORE RICHARD McGILL, ALJ:

This matter is a billing dispute between Stanislav Borukovich and Suez Water New R. Lambert Jersey. The matter was transmitted to the Office of Administrative Law on April 26, 2016, J. Gerson for determination as a contested case.

On the hearing date, the parties agreed to an amicable resolution of the matter and submitted a Stipulation of Settlement. Having reviewed the record and the settlement terms, I FIND as follows:

OAL DKT, NO. PUC 06292-16

- 1. The parties have voluntarily agreed to the settlement as evidenced by their signatures or the signatures of their representatives.
- 2. The settlement fully disposes of all issues in controversy and is consistent with the law.

Therefore, I **CONCLUDE** that the agreement meets the requirements of <u>N.J.A.C.</u> 1:1-19.1 and that the settlement should be approved. Accordingly, it is **ORDERED** that the parties comply with the terms of the settlement, and it is **FURTHER ORDERED** that the proceeding in this matter be concluded.

I hereby FILE my initial decision with the BOARD OF PUBLIC UTILITIES for consideration.

This recommended decision may be adopted, modified or rejected by the BOARD OF PUBLIC UTILITIES, which by law is authorized to make a final decision in this matter. If the Board of Public Utilities does not adopt, modify or reject this decision within forty-five (45) days and unless such time limit is otherwise extended, this recommended decision shall become a final decision in accordance with N.J.S.A. 52:14B-10.


