BY THE BOARD:

On September 18, 2000, United Telephone Company of New Jersey, Inc. (Petitioner or UNJ) filed a petition with the Board of Public Utilities (Board) to delete certain Uniform Service Order Codes (USOCs), and to make other non-rate affecting tariff clarifications.

The USOCs proposed for deletion are no longer needed since a billing enhancement was made that significantly reduced the number of USOCs used for provision of switched and special access. Continuation of these codes could cause confusion since in some cases, one USOC currently represents several different rates. Also included are minor changes, which improve page formatting and remove a portion of a rate table which should have been removed previously when earlier changes were made to the maintenance of service charges.

Since no rates will be changed, no existing customer will be affected by removing the USOCs involved. The tariff clarifications serve only to improve tariff usefulness and customer flexibility. Therefore, the proposal has no affect on Petitioner's ability to provide safe, adequate, or proper service.

The Board therefore, FINDS that Petitioner's request should be granted and HEREBY APPROVES Petitioner's request.




