BY THE BOARD:

This Order memorializes action taken by the Board of Public Utilities (Board) at its April 08, 2008 Agenda Meeting. The Board of Public Utilities' Customer On-Site Renewable Energy (CORE) program offers prescribed financial incentives to New Jersey property owners to

encourage the installation of Class I renewable energy technologies. Eligible applicants may receive rebates for a portion of the cost of installing solar, wind or sustainable biomass at their site.

The Staff of the Office of Clean Energy (OCE) has reviewed the applications under the CORE Program described herein the amount of monetary rebate requested. In addition, Honeywell, the Contract Market Manager, executed appropriate documentation affirming that, consistent with the terms of its contract, Honeywell is not acting as both the Contract Market Manager and a market participant in any of the CORE rebate applications submitted for Board approval. The signed documents are appended to this Order. Therefore, the OCE finds that each application is complete and fully conforms to all Board eligibility requirements for a rebate commitment under this program.


