Dear Members of the NJ Board of Public Utilities:

I am writing in regard to the proposed settlement between the BPU and Verizon. As a farmer living in Stow Creek, NJ, Cumberland County, I can tell you what a difference Broadband Internet access through Verizon's FIOS has made in my farm operation. Prior to FIOS, my only means of access to market information was through my dial up modem which took at least twenty minutes to access the particular information I needed. To download any educational information put out by a Land Grant University such as Rutgers was impossible because anything with pictures was too big a file to download. While I am thankful for broad band access at my farm, my friends and neighbors in adjacent communities are without access to this technology. This adversely affects their farming operations. While they can access the internet through dial up, satellite or in some cases, Comcast (Shiloh borough), the speed, dependability and expense of this access varies widely and does not provide a stable access that a business needs in order to remain profitable and compete locally, regionally, nationally or even globally. If the PBU accepts the Stipulation of Settlement as written, there will be no expansion of the fiber optic network inspite of the billions of dollars collected from ratepayers for full build out of broadband infrastructure in New Jersey. Verizon took our money and now wants to back out of the agreement they made in their commitment to Opportunity NJ. That is not right.

Verizon considers 4 G based wireless service as broadband access so if a home or business is in an area served by 4 G wireless (no matter how spotty), then no fiber optic wire is required. Even though the internet can be accessed with wireless devices, the bandwidth is not sufficient to conduct business or to enable students to do their homework.

The Verizon Wireless service coverage map at their website shows better coverage than actually exists. Many areas of our county have non-existent or spotty, unreliable service. In a call to a fellow farmer who was on his land in Greenwich this morning, the call went through and then was dropped because of poor signal strength. That is typical of 4 G coverage in the area.

Wireless 4 G communication is expensive. Unlike wired b roadband access like FIOS, the wireless access is subject to data cap pricing making it a much more expensive solution. This handicaps small business and families with children who have to pay more for 4 G internet access than farms and families with wired broadband access. It puts businesses at a disadvantage and it puts rural families at a disadvantage. As time goes by, more and more is being done through the internet. Try filing your payroll taxes without the internet. It isn't a luxury anymore. It is a necessity for education and for doing business.

The definition of broadband put forth in this settlement is seriously outdated and does not meet the current federal standard. Cumberland County is already the poorest county in the state. It should not be relegated to third class citizenry because it is denied access to meet current standards recognized by the federal government. Any attempt to define broadband should recognize that the speed benchmark will continue to increase as consumer demand grows.

DSL access over deteriorating copper lines is not an option. Loss of connection is so frequent that it becomes unusable. Time has value. If your connection is constantly being lost, you lose valuable time just trying to do the absolute minimum on the internet.

Cumberland County is a rural area where the expansion of fiber optic lines will not bring a return like urban areas do. However the people of this state have committed millions of dollars to farmland preservation and our county ranks fifth in acres of preserved land. This preservation of open space is important to the residents of the state, but the people and businesses of this area should not be penalized for living in these areas. The broadband needs of this area must be met even though there may not be as great a return to Verizon as in an urban area. Farmers and nursery growers cannot move where they grow their crops and conduct their farm businesses so that means the broadband infrastructuremust come to the farmers and nursery growers. Without access to broadband internet, our farmers and nursery growers are at a competitive disadvantage locally, regionally, nationally and internationally. In a depressed area such as Cumberland County, we need to do all we can to help our businesses remain competitive and to develop.

Please see that Verizon honors its agreement to Opportunity New Jersey and brings broadband access to all the areas of New Jersey including the rural areas. Reject the proposed Stipulation of Agreement between the BPU and Verizon and force a third party audit of Verizon's actuall coverage, not what the company claims.

#### Dear Ms. Izzo:

I am writing this as a member of the Cumberland County Board of Agriculture, member of the Cumberland County Agriculture Development Board, member of Rutgers Board of Managers and as a business owner of **Woodland Produce** in Fairton New Jersey. Comcast wants \$25.000.00 to run their line 1200 feet to my business. My Verizon 4G LTE is only available about 50 percent of the time (I have been monitoring this for 2 years) then drops to 3G. My landline is unusable during and after rain storms, and my DSL goes out every time there is a thunderstorm. I am at a disadvantage in trying to run my business. Why should agricultural business be at more of a disadvantage than they already are just because Verizon does not want to fulfill their agreement. I have been on the list to be notified as soon as Fios is available in my area (for years), but to no avail. If this is allowed to past, I will never see Fios. **Why penalize agriculture?** I also could not afford to run my business and household on any current 4G plan now available from Verizon.

Several other rural areas throughout Cumberland remain cut off from the enabling technologies necessary for business growth at a time when economic growth is urgently needed. The opportunities for farm businesses are of such magnitude that we are compelled to voice our strong opposition to the proposed Stipulation of Settlement in the above referenced matter. The confluence of several factors, fueled by the growing consumer demand for local fresh food and on-farm activities, means that the Garden State can ill afford to support the current technological stranglehold on its food and agriculture industry. Specific concerns and reasons for opposition are as follows:

1. The Broadband Request Process is one that <u>relies on flawed coverage data</u> and will yield disastrous decisions for rural agricultural communities. Verizon has consistently overstated its cellular coverage, both on its website and as reported to the state under the State Broadband Initiative. They are not alone; overstated cellular coverage, combined with the overstated coverage data submitted by Comcast (our only other service provider of wire-based access) will effectively exclude our agricultural areas from any wire-based telecommunications infrastructure build out. We implore the BPU to validate broadband coverage data via an objective third party with the appropriate telecommunications expertise.

- 2. Farmers already using DSL, satellite, or wireless Internet access know firsthand that <u>these access</u> <u>methods are insufficient for current operations</u> let alone the growing data demands of precision agriculture, a management practice that improves soil inputs, meets environmental constraints, and increases profitability. In addition to being inadequate, data cap pricing and/or limits make cellular and/or satellite solutions more expensive. Precision agriculture calls for robust telecommunications infrastructure, i.e., "fiber to the farm, wireless to the tractor." We implore the BPU to hold Verizon to a higher standard, both in terms of the access medium and in the definition of broadband.
- 3. The smaller the area of telecommunications deficiency, the greater the risk to existing businesses because they lose their ability to compete on any level: locally, regionally, nationally, or globally. This is especially true for farms, because a farmer cannot relocate his/her land to where the infrastructure exists; the infrastructure must come to the farmer.
- 4. Communities successful in the preservation of farmland and open space are penalized for being good stewards of the land. Because these communities will never have the population densities to costjustify telecommunications build out, there must be some *quid pro quo* consideration built into each and every state/service provider agreement affecting the deployment of current technologies; otherwise, the state inadvertently compromises the public's investment in farmland preservation by not ensuring that farm businesses remain viable over the long term. ]
