





provide the Division with proof that he has satisfied his outstanding New Jersey Division of Unemployment and Disability Insurance (“**NJ DUDI**”) debt by June 15, 2014; and

IT IS FURTHER ORDERED that that the approval of Applicant’s initial casino key employee license is specifically conditioned upon Applicant’s compliance with his voluntary agreement to provide the Division with proof having satisfied his outstanding NJ DUDI debt by June 15, 2014, by sending a copy of all relevant documentation, including proof of payment, to:
