CORRECTED DECISION

List Revival and Extension

The Judiciary requests the revival and extension of the eligible lists for Investigator (S0049N) and Investigator, Bilingual in Spanish and English (S0050N), Statewide.

By way of background, the Investigator (S0049N), Statewide, eligible list promulgated on June 2, 2011 and expired on June 1, 2014. The list was certified 39 times and resulted in 74 appointments, and 863 eligibles remain on this list. In addition, the Investigator, Bilingual in Spanish and English (S0050N), Statewide, eligible list promulgated on Jun 2, 2011 and expired on June 1, 2014. The list was certified 26 times and resulted in 26 appointments, and 116 eligibles remain on the list. It is noted that various certifications remain outstanding for both lists.

In the instant request, the Judiciary asks that the subject eligible lists be revived and extended for six months since vacancies for those titles are anticipated. The Judiciary states that it would experience a hardship if it is required to delay making appointments until this agency has finished with the examination process. It is noted that this agency received the request on June 20, 2014, after the expiration date of the subject lists. The Division of Selection Services and Recruitment (Selection Services) supports the Judiciary's request to extend the current lists until new lists can be generated from the new announcements.

CONCLUSION

N.J.S.A. 11A:4-6 and N.J.A.C. 4A:4-3.3(b)1 provide that an eligible list may, for good cause, be extended, except that no list shall have a duration of more than four years.

In the instant matter, the Judiciary seeks the extension of the Investigator (S0049N) and Investigator, Bilingual in Spanish and English (S0050N), Statewide, eligible lists, so that it can fill future vacancies from the existing eligible lists. The Civil Service Commission (Commission) notes that the filling of vacancies through permanent appointments from an active eligible list is preferable to making provisional appointments. Accordingly, the Commission finds that good cause has been presented to extend the eligible lists for Investigator (S0049N), Statewide, and Investigator, Bilingual in Spanish and English (S0050N), Statewide, until a new list can be issued or until the subject list has reached the statutory duration of four years, whichever comes first.

ORDER

Therefore, it is ordered that this request be granted, and the eligible lists for Investigator (S0049N), Statewide, and Investigator, Bilingual in Spanish and English (S0050N), Statewide be extended until a new list can be issued or until the subject list has reached the statutory duration of four years, whichever comes first.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.
