**Examination Appeal**

Robert Liwacz appeals the determination of the Division of Agency Services (Agency Services) that he was below the minimum requirements in experience for the promotional examination for Manager 2 Department of Law and Public Safety (PS2310P), Division of State Police.

The examination at issue was announced with specific requirements that had to be met as of the March 21, 2016 (see attached). A total of three employees applied for the subject examination and each was deemed ineligible. Accordingly, the examination was cancelled due to a lack of qualified applicants.

On his application, Mr. Liwacz indicated that he was provisionally serving in the subject title from March 2015 to the March 21, 2016 closing date, a Chief Public Safety Telecommunicator from June 2009 to March 2015, a Supervising Public Safety Telecommunicator from October 2004 to June 2009, a Senior Public Safety Telecommunicator from December 1998 to October 2004, a Public Safety Telecommunicator from December 1996 to December 1998, a Communications Operator from August 1983 to December 1996, a Senior Guard from December 1982 to August 1983, and a Guard from May 1982 to December 1982. Personnel records indicate that he was provisionally serving in the subject title from March 2015 to the March 21, 2016 closing date, a Chief Public Safety Telecommunicator from June 2009 to March 2015, a Supervising Public Safety Telecommunicator from October 2004 to June 2009, a Senior Public Safety Telecommunicator from December 1998 to October 2004, a Public Safety Telecommunicator from December 1996 to

December 1998, a Communication Operator from October 1990 to December 1996, a Police Officer from March 1990 to October 1990, a Communications Operator from August 1983 to March 1990, a Guard from February 1983 to August 1983, a Senior Guard from July 1982 to February 1983, and a Guard from May 1982 to July 1982. He did not indicate that he possesses a Bachelor's degree. Agency Services credited him with 6 years and 10 months of general experience and having met the supervisory experience requirements, but determined that he lacked 2 years and  $2^1$  months of general experience.

On appeal, Mr. Liwacz presents that while serving as a Supervising Public Safety Telecommunicator, he was performing the duties of a Chief Public Safety Telecommunicator as indicated by Agency Services' February 2, 2010 determination letter which he attaches. He also submits letters from Lieutenant Robert Forrester, Assistant Bureau Chief, Communication Bureau, and Major David Brady, Commanding Officer, Emergency Management Section, on behalf of Colonel Joseph Fuentes, Superintendent, which confirm that the appellant was performing the required duties out-of-title as a Supervising Public Safety Telecommunicator since October 2004 due to the appointing authority's operational needs and the attrition, consolidation, and constriction of positions across State government.

## CONCLUSION

N.J.A.C. 4A:4-2.6(a) provides that applicants shall meet all requirements specified in the promotional announcement by the closing date. N.J.A.C. 4A:4-2.6(c) provides that, except when permitted for good cause, applicants for promotional examinations with open-competitive requirements may not use experience gained as a result of out-of-title work to satisfy the requirements for admittance to the examination or for credit in the examination process.

Initially, it is noted that Agency Services correctly determined that the appellant was not eligible for the subject examination. The appellant was credited with 6 years and 10 months of experience and having met the supervisory experience requirement, but he lacked 2 years and 2 months of the required experience needed to establish eligibility. Any relevant experience the appellant gained as a Supervising Public Safety Telecommunicator would be out-of-title-work. However, Lieutenant Forrester and Major Brady confirmed that he had been performing the required out-of-title duties as a Supervising Public Safety Telecommunicator from October 2004 due to the appointing authority's operational needs and the attrition, consolidation, and constriction of positions across State government. Additionally, the examination was cancelled due to a lack of qualified applicants and the appellant continues to serve provisionally in the title under test.

Accordingly, good cause exists to accept the appellant's out-of-title work experience, for eligibility purposes only, and to admit him to the examination.

# **ORDER**

Therefore, it is ordered that the appeal be granted, and Robert Liwacz's application be processed for prospective employment opportunities only.

This is the final administrative determination in this matter. Any further review should be pursued in a judicial forum.

Open to employees in the competitive division who have an aggregate of one year of continuous permanent service as of the closing date in any competitive title and meet the requirements listed below:

Education: Graduation from an accredited college or university with Bachelor's degree. You must indicate either possession of a degree or total number of college credits completed to date on your application. (Foreign degrees/ transcripts must be evaluated by a recognized evaluation service.) Failure to do so will result in rejection from the examination process.

Experience: Five (5) years of experience in program management, two (2) years of which shall have been in a supervisory capacity.

Note: A Master's degree in various fields of study relevant to human resources, administration, management, business and commerce, public affairs, accounting and finance, date processing/computer sciences, or related fields denoting program management and concepts may be substituted for one (1)year of indicated non managerial/supervisory experience.
