SUBJECT: Change in Classification Plan

LOCAL GOVERNMENT

The Department of Health and Senior Services (DHSS), on behalf of the local Women, Infants and Children (WIC) agencies, requests the creation of a new title to provide breastfeeding support and promotion services to participating clients of local WIC Programs.

WIC funding is provided by the United States Department of Agriculture to State agencies, who in turn are responsible for distributing funds and implementing programs appropriate to the needs of the client population served.

A thorough search of title files revealed there is no existing title to appropriately classify this function, outlined in Federal WIC Program Consolidated Regulations, 7 CFR 246.11. Included in these regulations are the requirements that the information provided through the program be taught in the context of the ethnic, cultural and geographic preferences of the participants and with consideration for educational and environmental limitations experienced by the participants and taking reasonable steps to include materials in languages other than English in areas where a significant number or proportion of the population needs the information in a language other than English. A past or present WIC participant is preferred as a Counselor.

The new title is recommended for placement in the non-competitive branch of the career service in accordance with NJAC4A:3-1.2(c) in that the duties and requirements are unique, such that competitive testing is impracticable.

Specifically, appointees to positions performing this function must meet the following criteria –

- Have previous breastfeeding experience.
- Be enthusiastic about breastfeeding.
- Speak the language of the population served.

- Have reliable transportation.

ACTION: The Civil Service Commission directed that this appeal be denied.

Frederick Foy appeals the decision of the Division of State and Local Operations that the proper classification of his position with the Department of the Treasury is Supply Support Technician 1. The appellant seeks a Storekeeper 1 classification.

B-20 MARILYN BOYCE

The appeal of Marilyn Boyce, a Human Services Assistant at Ancora Psychiatric Hospital, Department of Human Services, of her removals, effective January 6, 2010, on charges, was heard by Administrative Law Judge Edward J. Delanoy, Jr. (ALJ), who rendered his initial decision on March 5, 2012. At its meeting on April 4, 2012, the Civil Service Commission (Commission) did not adopt the ALJ's recommendation to modify the removals to a 90-day suspension and a 180 calendar day suspension. Rather, the Commission modified the first removal to a 180 calendar day suspension and upheld the second removal. The proposed final decision is now submitted for the Commission's review.

B-37 CHARLES RICHTER

In response to a motion filed by the Civil Service Commission, the Appellate Division, Superior Court of New Jersey, has remanded for reconsideration the appeal of Charles Richter, a former Laborer with the Borough of Milltown, represented by Kevin P. McGovern, Esq., regarding the decision rendered on November 23, 2010, where the Director of the Division of Merit System Practices and Labor Relations denied his request for a hearing with respect to his removal effective July 29, 2010.

ACTION: The Civil Service Commission directed that this request for reconsideration be denied.

B-38 EDWARD HAAS

Edward Haas, a Deputy Attorney General 4 with the Office of the Attorney General, Department of Law and Public Safety, represented by Andrew L. Watson, Esq., appeals the determination of the Chief of Staff of the Office of the Attorney General, stating that the appellant failed to present sufficient evidence to support a finding that he had been subjected to violations of the New Jersey State Policy Prohibiting Discrimination in the Workplace.

ACTION: The Civil Service Commission directed that this appeal be denied, but the matter of the classification of the appellant's position be referred to the Division of State and Local Operations for review.

B-39 MELISSA FRATELLA

The appeals of Melissa Fratella, a County Correction Officer with the Morris County Sheriff's Office, of her 180-day suspension, on charges, and of her removal effective December 10, 2010, on charges, were heard by Administrative Law Judge Barry E. Moscowitz (ALJ), who rendered his initial decision on February 29, 2012. At its meeting on April 4, 2012, the Civil Service Commission did not adopt the ALJ's recommendation to reverse the 180-day suspension and modify the removal to a 90-day suspension. Rather, the Commission upheld the appellant's 180-day suspension and removal. The proposed final decision is now submitted for the Commission's review.
