**RECOMMENDATION OF THE ADMINISTRATIVE LAW JUDGE IN  
THE ABOVE CASES – SETTLEMENTS**

**ACTION:** The Civil Service Commission acknowledged the settlements.

**A-2 ELMORE GAINES**

Elmore Gaines, Code Enforcement Officer, City of Newark, Department of Neighborhood and Recreational Services, four-month suspension on charges of incompetency, inefficiency or failure to perform duties, insubordination, conduct unbecoming a public employee and other sufficient cause.

Recommendation of the Administrative Law Judge – Uphold the four-month suspension.

**ACTION:** The Civil Service Commission modified the recommendation of the Administrative Law Judge and imposed a six-month suspension.

**A-3 JOHN D. KOHLER**

John D. Kohler, Senior Maintenance Repairer, Cape May County, Department of Facilities and Services, 30 working day suspension and demotion to the position of Maintenance Repairer effective January 27, 2012, on charges of conduct unbecoming a public employee and Workers Compensation fraud.

Recommendation of the Administrative Law Judge – Reverse the 30 working day suspension and demotion to the position of Maintenance Repairer.

**ACTION:** The Civil Service Commission affirmed the recommendation of the Administrative Law Judge.

**A-4 SHAWN PRESSLEY**

Shawn Pressley, Assistant Family Service Worker 3, Department of Children and Families, release at the end of the working test period effective November 9, 2011.

Recommendation of the Administrative Law Judge – Reverse the release at the end of the working test period.

**ACTION:** The Civil Service Commission directed that this matter be held over.

**A-5 JOHN VENABLES, JR.**

John Venables, Jr., Police Lieutenant, City of Camden, Police Department, a 15-day suspension and six-month suspension and demotion to the position of Police Sergeant effective September 28, 2009, on charges of violation of the Department rules and regulations, insubordination and other sufficient cause.

Recommendation of the Administrative Law Judge – Reverse the 15-day suspension, modify the six-month suspension to a 90-day suspension and reverse the demotion to the position of Police Sergeant.

**ACTION:** The Civil Service Commission modified the recommendation of the Administrative Law Judge and reversed the 15-day suspension and the demotion to the position of Police Sergeant but upheld the six-month suspension.

**A-6 ANNIE BAKER**

Annie Baker, Correction Sergeant, Juvenile Justice Commission, removal effective April 24, 2012, on charges of inability to perform duties and other sufficient cause.

Recommendation of the Administrative Law Judge – Uphold the removal.

**ACTION:** The Civil Service Commission affirmed the recommendation of the Administrative Law Judge.

**A-7 JACQUELINE BYRD**

Jacqueline Byrd, Senior Food Service Worker 12 months, Trenton Psychiatric Hospital, Department of Human Services, removal effective June 25, 2012, on charges of conduct unbecoming a public employee, other sufficient cause, physical or mental abuse of a patient, client, resident or employee, verbal abuse of a patient, client, resident or employee, inappropriate physical contact or mistreatment of a patient, client, resident or employee and intentional abuse or misuse of authority or position.

Recommendation of the Administrative Law Judge – Uphold the removal.

**ACTION:** The Civil Service Commission affirmed the recommendation of the Administrative Law Judge.

**A-8 TODD PICKETT SETTLEMENT (REMAND)**

Todd Pickett, Fire Fighter, City of Passaic Fire Department, removal effective July 1, 2012 on charges of incompetency, inefficiency or failure to perform duties, inability to perform duties, chronic or excessive absenteeism or lateness, conduct unbecoming a public employee, neglect of duty and other sufficient cause. Settled to a retirement effective October 1, 2012.

Recommendation of the Administrative Law Judge – Acknowledge the settlement.

**ACTION:** The Civil Service Commission affirmed the recommendation of the Administrative Law Judge.

**A-9 PETER MUNIZ**

Peter Muniz, Fire Fighter, City of Newark, Fire Department, removal effective April 13, 2007, on charges of conduct unbecoming a public employee, formal charges of a crime of the first, second, or third degree, other sufficient cause and violation of Fire Department rules and regulations.

Recommendation of the Administrative Law Judge – Uphold the removal.

**ACTION:** The Civil Service Commission affirmed the recommendation of the Administrative Law Judge.



**A-10 KEITH WICKHAM, JR.**

Keith Wickham, Jr., Senior Correction Officer, New Jersey State Prison, Department of Corrections, removal effective October 15, 2012, on charges of incompetency, inefficiency or failure to perform duties, conduct unbecoming a public employee, neglect of duty, other sufficient cause, serious mistake due to carelessness which may result in danger and/or injury to persons or property, falsification, and improper or unauthorized contact with inmate, undue familiarity with inmates, paroles, their families or friends.

Recommendation of the Administrative Law Judge – Modify the removal to a six-month suspension.

**ACTION:** The Civil Service Commission directed that this matter be remanded to the Office of Administrative Law.

**SECTION B – MISCELLANEOUS MATTERS****B-1 DANIEL S. BALDASSANO**

Daniel S. Baldassano, represented by Robert J. DeGroot, Esq., appeals his rejection as a Police Officer candidate by Woodbridge Township and its request to remove his name from the eligible list for Police Officer (S9999M) on the basis of psychological unfitness to perform effectively the duties of the position.

**ACTION:** The Civil Service Commission directed that this matter be referred for an independent evaluation.

**B-2 ANTHONY MEDINA**

Anthony Medina, represented by Stephen B. Hunter, Esq., appeals his rejection as a Fire Fighter candidate by Elizabeth and its request to remove his name from the eligible list for Fire Fighter (M2339H) on the basis of psychological unfitness to perform effectively the duties of the position.

**ACTION:** The Civil Service Commission directed that this appeal be denied.

**B-3 EDWARD PICKETT**

Edward Pickett, represented by Daniel J. Zirrith, Esq., appeals his rejection as a Fire Fighter candidate by Jersey City and its request to remove his name from the eligible list for Fire Fighter (M2365H) on the basis of psychological unfitness to perform effectively the duties of the position.

**ACTION:** The Civil Service Commission directed that this appeal be denied.

**B-4 RYAN LOPEZ**

Ryan Lopez, a former Senior Medical Security Officer with Ann Klein Forensic Center, Department of Human Services, appeals his five-day suspension.

**B-10 MEGHAN BERKERY, ET AL**

The Department of Children and Families requests that Meghan Berkery, Ashley Mystila, Andrea Smith and Precella Speid be added to the promotional list for Family Service Specialist 1 (PS3420K).

**ACTION:** The Civil Service Commission directed that this request be granted.

**B-11 JERRY CALABRESE AND MICHAEL GILLENS**

Jerry Calabrese, represented by Edward G. D'Alessandro, Esq., and Michael Gillens, represented by Bette R. Grayson, Esq., appeal the determinations of the Division of Selection Services, which found that they were ineligible for the promotional examination for Police Captain (PM7534P), Newark.

**ACTION:** The Civil Service Commission directed that these appeals be denied.

**B-17 HUMAN SERVICES SPECIALIST 4 (PC0941M)**

The Mercer County Board of Social Services requests that the eligible list for Human Services Specialist 4 (PC0941M) be extended for one year beyond its original expiration date.

**ACTION:** The Civil Service Commission directed that this request be granted.

**B-18 HUMAN SERVICES SPECIALIST 4 (PC0251N)**

The Camden County Board of Social Services requests that the eligible list for Human Services Specialist 4 (PC0251N) be extended for one year beyond its original expiration date.

**B-19 POLICE CAPTAIN (PM7521P), JACKSON TOWNSHIP**

*In In the Matter of Public Health Investigator (C0964L), Ocean County Health Department (CSC, Decided February 16, 2011), the Civil Service Commission granted the appointing authority's request for an appointment waiver from the April 20, 2010 certification and ordered that no selection costs would be assessed at that time since there was a possibility that the list could be utilized prior to its expiration. **ACTION:** The Civil Service Commission ordered the appointing authority to remove the provisional appointee, properly dispose of the certification, and pay compliance costs.

**B-22 SENIOR INVESTIGATOR PAROLE AND SECURED FACILITIES (PC0797M), HUDSON COUNTY**

The appointing authority's failure to dispose of the certification for Senior Investigator Parole and Secured Facilities (PC0797M), Hudson County, while a provisional is serving in the title, has been referred to the Civil Service Commission for enforcement.

**ACTION:** The Civil Service Commission ordered the appointing authority to properly dispose of the certification and pay compliance costs.

**B-23 SOCIAL SERVICE TECHNICIAN (C0166P), BERGEN COUNTY BOARD OF SOCIAL SERVICES**

Bergen County Board of Social Services requests permission not to make an appointment from the November 26, 2012 certification for Social Service Technician (C0166P).

**ACTION:** The Civil Service Commission directed that this request for an appointment waiver be granted and assessed no selection costs.

**B-24 STATE PARK POLICE OFFICER TRAINEE PILOT PROGRAM**

The Department of Environmental Protection (DEP) requests that the Civil Service Commission establish a Pilot Program to provide for the promotion of permanent DEP employees to the title of State Park Police Officer Trainee.

**ACTION:** The Civil Service Commission established the State Park Police Officer Trainee Pilot Program for the period from April 6, 2013 to April 5, 2014.

**B-25 ROBERT BEAUREGARD**

Robert Beauregard, an Assistant Director with the Department of the Treasury, appeals the determination of the Office of Equal Employment Opportunity and Affirmative Action, which found that the appellant had violated the New Jersey State Policy Prohibiting Discrimination in the Workplace.

**ACTION:** The Civil Service Commission directed that this appeal be granted.

**B-26 JOSEPHINE FARINA**

Josephine Farina, a Personnel Assistant 1 with the former Department of Health and Senior Services, appeals the determination of the Commissioner of the Department of Health and Senior Services, stating that the appellant failed to present sufficient evidence to support a finding that she had been subjected to violations of the New Jersey State Policy Prohibiting Discrimination in the Workplace.

**ACTION:** The Civil Service Commission directed that this appeal be granted in part.

**B-27 COLLEEN FITZGERALD**

Colleen Fitzgerald, a former Assistant Social Work Supervisor (Psychiatric) with the Ann Klein Forensic Center, Department of Human Services, appeals the determination of the Assistant Commissioner, DHS, stating that there was sufficient evidence to support a finding that the appellant had violated the New Jersey State Policy Prohibiting Discrimination in the Workplace.

**ACTION:** The Civil Service Commission directed that this appeal be denied.

**B-28 LULA HENRY**

Lula Henry, a former Charge Nurse (12 Months) with the Department of Human Services, appeals the determination of the Assistant Commissioner, DHS, stating that she failed to present sufficient evidence to support a finding that she had been subjected to a violation of the New Jersey State Policy Prohibiting Discrimination in the Workplace.

**ACTION:** The Civil Service Commission directed that this appeal be denied.



**B-29 BARINDERJIT K. BAL**

The appeal of Barinderjit K. Bal, a former Library Associate with the Bloomfield Public Library, of her layoff, effective October 3, 2011, was before Administrative Law Judge Michael Antoniewicz (ALJ), who rendered his initial decision on April 19, 2013. At its meeting on May 15, 2013, the Civil Service Commission affirmed the ALJ's recommendation to uphold the layoff. However, the Commission needed to address the exceptions and cross exceptions filed by the parties. The proposed final decision is now submitted for the Commission's review.

**ACTION:** The Civil Service Commission adopted the final decision.

**B-30 ALEXANDER LOIZOS**

The appeal of Alexander Loizos, a Correction Officer Recruit at New Jersey State Prison, Department of Corrections, of his removal, effective October 1, 2012, on charges, was heard by Administrative Law Judge John R. Futey (ALJ), who rendered his initial decision on April 5, 2013. At its meeting on May 15, 2013, the Civil Service Commission affirmed the recommendation to modify the removal to a 180 calendar day suspension. However, the Commission needed to address the exceptions and cross exceptions filed by the parties. The proposed decision is now submitted for the Commission's review.

**ACTION:** The Civil Service Commission adopted the decision.

**B-31 JAMES MCDONOUGH**

The appeal of James McDonough, a former Police Captain with the Town of Harrison, Police Department, of his demotion in lieu of layoff to Police Lieutenant effective April 5, 2010, was heard by Administrative Law Judge Michael Antoniewicz (ALJ), who rendered his initial decision on April 5, 2013. At its meeting on May 15, 2013, the Civil Service Commission adopted the ALJ's recommendation to uphold the layoff. However, the Commission needed to address the exceptions and cross exceptions filed by the parties. The proposed final decision is now submitted for the Commission's review.

**ACTION:** The Civil Service Commission adopted the final decision.

**B-32 WILLIAM BILLSON AND ALEXANDRA CALIFF**

Christopher J. Scaturo, Director/Chief, Division of Emergency Services, Union County, on behalf of William Billson and Alexandra Califf, petitions the Civil Service Commission for reconsideration of the part of the final administrative decision, rendered on April 17, 2013, in which the Commission found that Billson and Califf failed to indicate possession of the required certification for the open competitive examination for Hazardous Materials Responder (C0381P), Union County.

**ACTION:** The Civil Service Commission directed that this petition be granted.

**B-33 ALFONSINA COMUNE**

Alfonsina Comune, a former Executive Assistant 1 with the Office of Information Technology, requests reconsideration of the decision rendered on June 6, 2012, which found that the appellant failed to support a finding that she had been subjected to a violation of the New Jersey State Policy Prohibiting Discrimination in the Workplace (State Policy).

**ACTION:** The Civil Service Commission directed that this request for reconsideration be denied.

**B-34 LAURA MARTIN**

Laura Martin, a part-time Municipal Director of Welfare with the Borough of Edgewater requests reconsideration of the decision rendered on November 7, 2012, that determined she is not entitled to sick or vacation leave since she is serving in a title that is allocated to the unclassified service.

**ACTION:** The Civil Service Commission directed that this request for reconsideration be denied.

**B-35 YOLANDA N. PHILLIPS-HADDEN**

Yolanda N. Phillips-Hadden requests reconsideration of the final administrative determination, rendered on December 19, 2012, which upheld her ineligibility for the promotional examination for Supervisor, Child Care Quality Assurance Inspections (PS9795K), Department of Children and Families.

**ACTION:** The Civil Service Commission directed that this request for reconsideration be granted.

**B-36 SPECIAL LAW ENFORCEMENT OFFICERS, NEWARK SCHOOL DISTRICT**

The Director, Division of Classification and Personnel Management, requests reconsideration of the Civil Service Commission decision rendered on January 13, 2010, which ordered that 10 employees currently serving as "Special Police Officers" in the Newark School District be recorded as serving in the title of Campus Police Officer provisionally, pending the certification of the Campus Police Officer (S9999K), eligible list.

**ACTION:** The Civil Service Commission directed that this request for reconsideration be granted.

**B-37 HASAHYA HIRYA**

Hasahya Hirya appeals his score for the oral portion of the promotional examination for Fire Lieutenant (PM5189N), New Brunswick.

**ACTION:** The Civil Service Commission directed that this appeal be granted in part.

**B-38 JOHN HORNBACK, JR.**

John Hornback, Jr. appeals the determination of the former Division of Selection Services which found that he did not meet the experience requirements for the examination for Senior Engineering Aide (PC0782P), Camden County.

**ACTION:** The Civil Service Commission directed that this appeal be granted.

**B-39 LYNNETTE C. HUNT**

Lynnette C. Hunt appeals the determination of the Division of Selection Services which found that she did not meet the requirements for the promotional examination for Administrative Analyst 2 (PS6297K), Department of Human Services.

**ACTION:** The Civil Service Commission directed that this appeal be granted.

**B-40 JOHN LUCARIO**

Attached please find a Notice of Adoption of proposed new rule N.J.A.C. 4A:4-4.6A and proposed amendments to N.J.A.C. 4A:4-2.8, 2.17, 3.6, 6.1 and 6.2, intended to implement P.L. 2012, c.49, regarding placement on eligible lists of certain persons returning from military service. This new law addresses situations in which a reservist or a national guard member whose name had been placed on an open competitive eligible list returns from Federal active duty after the list has expired. The remedy provided in the legislation is to give such individuals the opportunity to request, within one year of the list's expiration, placement on an active eligible list for the same title and jurisdiction, utilizing the score he or she had earned for the expired list, for prospective appointment only. No comments were received during the public comment period.
