ENTRY-LEVEL LAW ENFORCEMENT STATE CORRECTION OFFICER RECRUIT

The current administration (symbol S9988T) announced on December 4, 2014 and the closing date was January 29, 2015. The exam is *tentatively* projected to be administered in April 2015. Candidates will be notified of their specific test date when examination notices are mailed, two to three weeks prior to the test date.

2014 Police Sergeant Examination Cycle

The current administration announced on January 1, 2014 and June 1, 2014; a targeted test administration date has not been determined. Our method of disseminating information to all interested parties (candidates, appointing authorities, and unions) is to advise them to visit the CSC's website, under Public Safety Testing News, to view the most up-to-date status report on police promotional testing schedules. When there is something new to report, the website status will be updated. We anticipate issuing an orientation guide well in advance of the test administration. The orientation guide will provide candidates with a description of the testing process along with tips and other information on how to prepare for the testing process.
