INTERIM APPOINTMENT

(INTERIM APPOINTMENT EXPIRES SEPTEMBER 30, 2017)

On Monday, October 29, 2012, Superstorm Sandy hit New Jersey, resulting in a level of damage never before experienced in this state. The Disaster Relief Appropriations Act (HR152) provided \$16 billion in funding to the Department of Housing and Urban Development (HUD) *Community Development Block Grant Disaster Recovery (CDBG-DR)* program; an initial allocation of \$1,829,520,000 was made to New Jersey. It is expected that there will be additional allocations of CDBG-DR to New Jersey by the HUD Secretary. The New Jersey Department of Community Affairs (DCA) will administer the CDBG-DR funds allocated to New Jersey to rebuild homes, businesses, and infrastructure impacted by Superstorm Sandy.

The DCA is seeking a Construction Code Inspector 2 to serve in the Sandy Recovery Division. A new interim division is to begin operations immediately and expected to remain operational through September 30, 2017.

DESCRIPTION OF MAJOR DUTIES:

Performs annual inspection of amusement rides, including mechanical and operational, and ski lifts. Reviews documentation to insure that all rides are assembled and operated according to the Carnival and Amusement Ride Safety Regulations, reviews more complex structural and mechanical aspects of amusements rides and ski lifts. Issues orders to cease violation of more complex devices and facilities; does other related duties as required.

REQUIREMENTS:

EXPERIENCE:

Seven (7) years of experience in construction project management work such as a construction manager, construction official, general contractor, architect, or engineer with field responsibilities for all levels of construction, OR as an electrician, plumber, building trades craftsman, fire protection specialist, amusement ride developer, or in construction, inspection, or boiler/pressure vessel maintenance, inspection or construction.

LICENSE:

Appointees will be required to possess a valid Industrial and Commercial Specialist (ICS) Code enforcement license in either; building, fire protection, electrical, or plumbing or boiler/pressure vessel and refrigeration, or amusement ride issued by the Department of Community Affairs, appropriate to the position.

NOTE: Appointees must continue to complete the continuing education requirements to maintain their ICS license.

NOTE: Appointees to the Liquefied Petroleum Gas Unit will be required to complete specialized training.

LICENSE: Appointees will be required to possess a valid driver's license only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.
