## **UNIFORM FIRE CODE REGISTRY SECOND QUARTER – APRIL 2016**

During the year 2016, we will publish three cumulative updates to this Registry consisting solely of changes. Although local jurisdiction is not effective until publication of an Annual or Quarterly Registry, we may assume jurisdiction at any time. The next deadline for changes to the Registry is June 30, 2016. After that date, a Third Quarterly Update will be published in July 2016.
