UNIFORM FIRE CODE REGISTRY THIRD QUARTER - JULY 2015

LEA REGISTRY

This Registry reflects changes in the Local Enforcing Agencies (LEAs) responsible for enforcing the Uniform Fire Code within the State of New Jersey as required under (N.J.A.C.5:70-1 et seq.) as of July 1, 2015.

During the year 2015, we will publish three cumulative updates to this Registry consisting solely of changes. Although local jurisdiction is not effective until publication of an Annual or Quarterly Registry, we may assume jurisdiction at any time. Therefore, if jurisdiction is of concern, please call (609) 633-7129 for confirmation.

The next deadline for changes to the Registry is September 30, 2015. After that date, a Fourth Quarterly Update will be published in October 2015.
