The sealed envelope must contain the name of the Contractor. If not submitting a bid proposal in accordance with the attached specifications, the outside of the above stated envelope shall be plainly marked "NO BID" when returned. Each bidder must clearly list the names and addresses of sub-contractors he shall utilize in the completion of this project. Failure to list subcontractors as required by the New Jersey Local Public Contracts Law will result in the bidder being disqualified. Bidders are required to comply with Agency requirements for qualified contractors by submitting a copy of their current contractor's liability insurance policy in the amount of at least \$500,000 property damage, \$500,000 bodily injury, \$100,000 workmen's compensation, Pollution Occurrence Insurance. Fidelity bonding with the limit of liability of at least \$279,600 shall be maintained by the recipient until all financial transactions under the LIHEAP grant are completed, and a copy of their certificate of registration with the New Jersey Division of Consumer Affairs.
