Please see below regarding additional response for Little Ferry.

- Need details on extent of excavation **This will also pertain to the second bullet point....Approximately six to twelve inches of soil to be removed across all field. The final figure will depend on final surveying and bidding requirements. The soil will be tested and anticipated to be found to be clean. As it will be clean fill, it will be utilized elsewhere in the Borough.**
- Need details on extent of soil removal and disposal **See above**
- Need details on turf system – why does artificial grass require a new underground irrigation system? **It doesn't**
- Need details on the installation of the lightning –poles will be installed, will excavation be need? **No. As the application stated, there are existing utility poles that will be removed. It is anticipated these holes will be reused. If not, an auger is used. There is no excavation.**
- Need detail on the installation of the fence, excavation needed? **No.**

Here are our thoughts on Perth Amboy. Let us know if you would like to discuss.

1. Construction of **new** restrooms and beach showers (new water/wastewater use) – need design drawings with elevation view, electrical, plumbing and extent of excavation
2. Construction of **new** fishing pier – need more information for inwater work
3. **New** 82' piles installed at marina – need more information for inwater work
4. Construction of **new or replacement** revetment wall? – excavation details and installation details needed

5. Replacement of the sidewalk – will there be an expansion in width?
6. **New** drip irrigation system for landscaping – more information is needed for this system, will they be using current plumbing lines? What is the extent of excavation?
7. Some work has already been done – will any of the EDA funding reimburse any of the expenses to date?
8. Refurbishment of the boat ramp – additional detail needed
9. There will be an increase in capacity/size of any existing structure or impervious surface – need additional information to determine percentage increase
10. Other **new** items include: volleyball courts, bleachers, kayak & canoe storage, beach showers (new water/wastewater use) at each entrance to the beach (how many?)
