Thank you for submitting the following request for National Register of Historic Places (NRHP) Section 106 Consultation Comments for the Keansburg Revitalization and Storm Mitigation Project – **Activity 1 (Stormwater Drainage Improvements).** The proposed project seeks to eliminate regular flooding and improve storm mitigation in Keansburg's commercial business district. Planned infrastructure improvements include the replacement of existing inlet pipes primarily within existing alignments and streetscape/grade adjustments to enhance drainage flow to water inlets. The application defines three distinct project locations as Outfall #11, Outfall #14

and Ph. II. The New Jersey State Historic Preservation Office (HPO) concurs there are no identified historic properties within the project Area of Potential Effect (APE).

800.4 Identification of Historic Properties

Thank you for submitting the following request for National Register of Historic Places (NRHP) Section 106 Consultation Comments for the Keansburg Revitalization and Storm Mitigation Project – **Activity 2 (Commercial Facade Improvements).** The proposed project seeks to rehabilitate 38 storm-damaged commercial properties along Main Street, Carr Avenue, Church Street and Beachway Avenue. Planned exterior work includes repointing brickwork, power washing exteriors, painting, replacing windows and doors, installing stucco, installing awnings and lighting and other minor repairs. The New Jersey State Historic Preservation Office (HPO)

agrees 22 of the 38 subject properties are located within identified Green Zones and are therefore exempt from review. HPO also agrees no new historic properties were identified during the assessment of the 16 non-exempt properties.

800.5 Assessment of Effects

HPO concurs that the proposed activities associated with the building façade improvements have low potential to affect existing above-ground historic properties, therefore, there are **no historic properties affected.** Consequently, pursuant to 36 CFR 800.4(d)(1), no further Section 106 consultation is required.
