Under the agreement we have with the NJ Field Office for review of HUD-funded Sandy projects, we are to request initiation of Section 7 consultation (or conference) with your office if we cannot reach a conclusion of "no effect" with respect to a proposed activity. For NLE bats, your office's guidance was that for activities that avoided clearing trees during the summer months, we could reach a no effects conclusions provided the clearing was less than 1 acre. For tree clearing that occurred during the summer months or that exceeded an acre in size, consultation/conference was recommended. Based on this guidance, the consultant preforming reviews of these projects requested conference with USFWS and received the attached response from you. They are now proposing to perform an acoustic survey to determine if NLE bats are in fact using the area, but are resisting the use of mist net surveys should their acoustic surveys reveal the presence of Myotis bats that could include NLE bats. At our meeting regarding forestry projects yesterday, you indicated that additional analysis of acoustic data may be sufficient to determine if NLE bats are included in the recording and negate the need for mist net surveys. Can you provide guidance with respect to this project if, as seems to be the case, they wish to proceed with tree clearing during the summer months?

In addition to this question about suitable surveys to reach a conclusion of "not likely to adversely affect," there is a larger issue being questioned here with respect activities that will occur while NLE bat is a "proposed" species and not yet listed. Section 7 of the ESA, requires the action agency to confer with the Secretary on any agency action which is likely to jeopardize the continued existence of any species proposed to be listed under section 4 or result in the destruction or adverse modification of critical habitat proposed to be designated for such species. Since no critical habitat is yet proposed, the requirement to confer only applies for actions that raise to the level of possibly jeopardizing the continued existence of the species. This begs the question as to what, if anything, would be required if the acoustic survey and/or mist netting revealed the presence of NLE bats on the site? I raise this because the question is being asked regarding mitigation measures for a very small area of disturbance possibly being less expensive than performing the surveys, especially if they must include mist net surveys.

So, to cut to the central questions:

1. can acoustic surveys alone be used to rule out NLE bat presence on a site, and, if so, what are the methods (number and timing of surveys, expertise required for species-specific resolution, etc.,)?

2. What mitigating measure would be required for clearing of ~ 1-2 acres of oak-pine forest in Ocean County if we assume that NLE bats are present on the site?
