The proposed action will include rehabilitation of one unit in a five-story, multi-unit residential structure containing more than four units. The property record for the structure provides a value of \$19,600,000, while the estimated cost of repairs including any work in place is \$35,058.17, resulting in a 0.18% improvement value. Therefore, as defined in 24 CFR 55.2(8)(i), the cost of repairing the structure is not considered to be a "substantial improvement" and will be considered a minor rehabilitation. A date of construction was not listed on county property records; however, historic aerial imagery reviewed by a URS architectural historian demonstrated that the present building was constructed between 1995 and 2002. The scope of the proposed action will include interior painting and the replacement and painting of doors and door components as well as the removal and replacement of smoke and carbon monoxide detectors, a water heater, and a toilet. Renovations will include addressing storm-related damage and bringing the unit up to current minimum property standards. All activities would be limited to the interior of the unit. Pre-award and pre-application activities are limited to work completed within the same existing footprint.
