SBL38840: The proposed project is the rehabilitation to maintain the operation of a public access marina. There are no structural changes to any buildings on the site. The parking area is in need of grading, weed matting and stoning with the addition of concrete vehicle stops. Rehabilitation will include removal of all floatation that is in need of replacement and/or repairs. Restoration is also needed for damaged and broken pilings, ramps and a bulkhead due to erosion due to Hurricane Sandy. A retaining wall in the parking lot needs repair as wells as dock mains and finger piers. A general cleanup of the waterway will also take place to remove trash, debris and damaged docks.
