

**EARLY NOTICE AND PUBLIC REVIEW OF A PROPOSED
ACTIVITY IN A 100-YEAR FLOODPLAIN**

To: All Interested Agencies, Groups & Individuals

This is to give notice that the New Jersey Department of Environmental Protection (NJDEP) on behalf of the Responsible Entity, the New Jersey Department of Community Affairs, has determined that the following proposed action under the Stronger New Jersey Business Loans (SBL) program developed by the state to rehabilitate or reconstruct storm-damaged properties by Superstorm Sandy, is located in the 100-year floodplain, and NJDEP will be identifying and evaluating practicable alternatives to locating the actions in the floodplain and the potential impacts on the floodplain from the proposed action, as required by Executive Order 11988, in accordance with HUD regulations at 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain Management and Protection of Wetlands.

Proposed action:

SBL39082: The proposed project is intended to complete the reconstruction of the property's docks and bulkheads to conformance with their pre-storm layout. The project will also provide funding to demolish several of the property's buildings, which are currently old and dilapidated, and construct eight new buildings. The project is located at 197 Princeton Avenue, Brick Township, Monmouth County, New Jersey. The property is located within the AE Flood Zone, as indicated on Flood Insurance Rate Map (FIRM) Panel 211 of 611 no. 34029C0211F, revised September 29, 2009.

There are three primary purposes for this notice. First, people who may be affected by activities in floodplains and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public education tool. Commenters are encouraged to offer alternative methods to serve the same project purpose, and methods to minimize and mitigate impacts. The dissemination of information and request for public comment about floodplains can facilitate and enhance Federal efforts to reduce the risks associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains, it must inform those who may be put at greater or continued risk.
