URS was tasked SBL39524, Providence Seashore House, LLC as a CEST level of review. Upon review of the provided application documents and a follow-up conversation with Ms. Leeanna Lozada, it is our understanding that one of the primarily goals of the project will be to renovate the building interior in order to expand the services available at the facility. The facility currently employs approximately 17 staff. Following renovations, the facility hopes to employ up to 36 staff (prior to the storm, in 2012, the facility employed 14-17 staff). The applicant also intends to add at least one (and possibly a second) 10' x 10' pre-fabricated storage shed to accommodate some of the facilities storage needs. With regard to this project qualifying as categorically excluded, we believe the project would best fit under 58.35 (a)(3)(iii), however, this CEST is only applicable when the facilities and improvements are in place and will not be changed in size or capacity by more than 20%. Given the placement of new storage buildings and the increased staffing capacity, we feel this project may need to be reviewed as an Environmental Assessment (EA) level of review. Please advise.
