All,

We are currently preparing an Environmental Assessment on behalf of the New Jersey Department of Environmental Protection (NJDEP) for the above-referenced HUD CDBG-DR funded project. This property is located at 487 Main Street in Dorchester, Maurice River Township, New Jersey. The applicant is seeking funding to construct new docks, piers and boat lifts. The applicant previously received an NJDEP Division of Land Use Regulation (DLUR) Waterfront Development Permit and a USACE Permit for their proposed work. In December, the applicant received extensions on both of these permits.

We are conducting an 8-Step Floodplain and Wetland Protection Review pursuant to HUD regulations to satisfy Executive Orders 11988 and 11990. Please refer to the attached public notice, which was published in local English and Spanish newspapers on February 13, 2015. I have also attached a site location map and copies of the approved permits, which include lists of proposed project activities and conditions for approval.
