Hi Bill and Kim,

I've attached a toxics site inquiry for NEP0231 and SRP0037411. The sites for NEP0231 were identified on the HUD mapping tool like we usually do.

The site for application SRP0037411 is located in Cumberland County, so the toxics sites are not mapped in the HUD tool. We decided (with Donna's input) to map potential toxic sites on Geoweb and then send to you for review.

I've attached the Geoweb map showing the site location and a 3000-foot buffer. There are 7 NJEMS sites within 3,000 feet, so I've also included the NJEMS report and listed these sites on the toxics spreadsheet. We have not identified any known contaminated sites, CEAs, or CKEs in Geoweb within 3000 feet of the site.
