We have another Superstorm Sandy CDBG-DR environmental assessment – SRP0041091 – that we are reviewing and would like your input. The site is located at 1492 Ocean Avenue Unit A-6, Sea Bright, NJ (Block 2.03, Lot 1.06 – I have included a GIS shapefile of the parcel). This application is for a single residential unit located within an apartment building. We do not have any specific site plans for this application, but the documentation provided in the application (see attached) indicates that the property was not substantially damaged, and that work will be limited primarily to interior repairs.

The property shows up on NJDEP's ArcGIS mapping as being within the Piping Plover buffer area (the USFWS's IPaC results also indicate Piping Plover may be within proximity to the project site). Notwithstanding this information, since the proposed work is limited primarily to interior repairs on a previously developed lot, we feel there will be no impact to this species.
