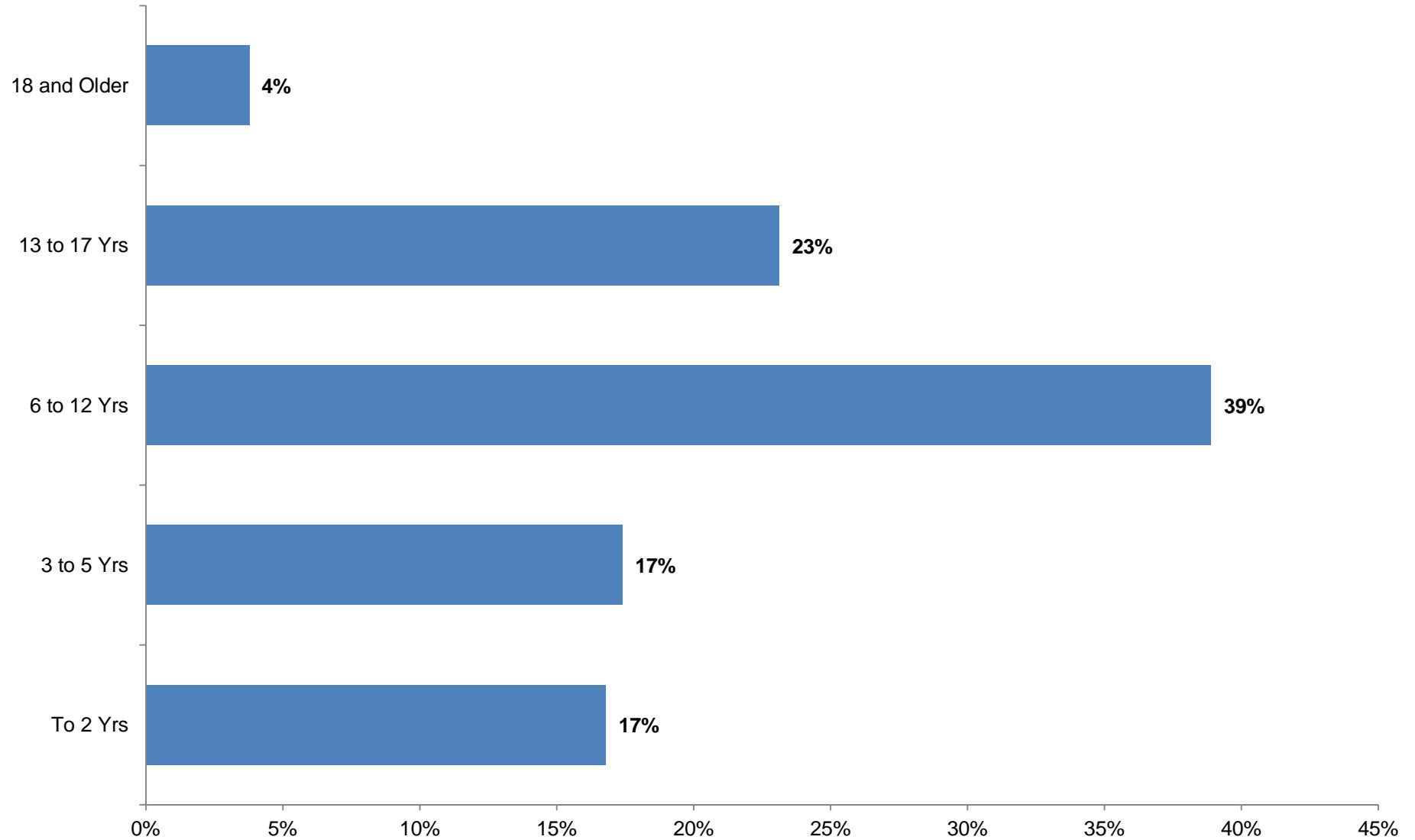

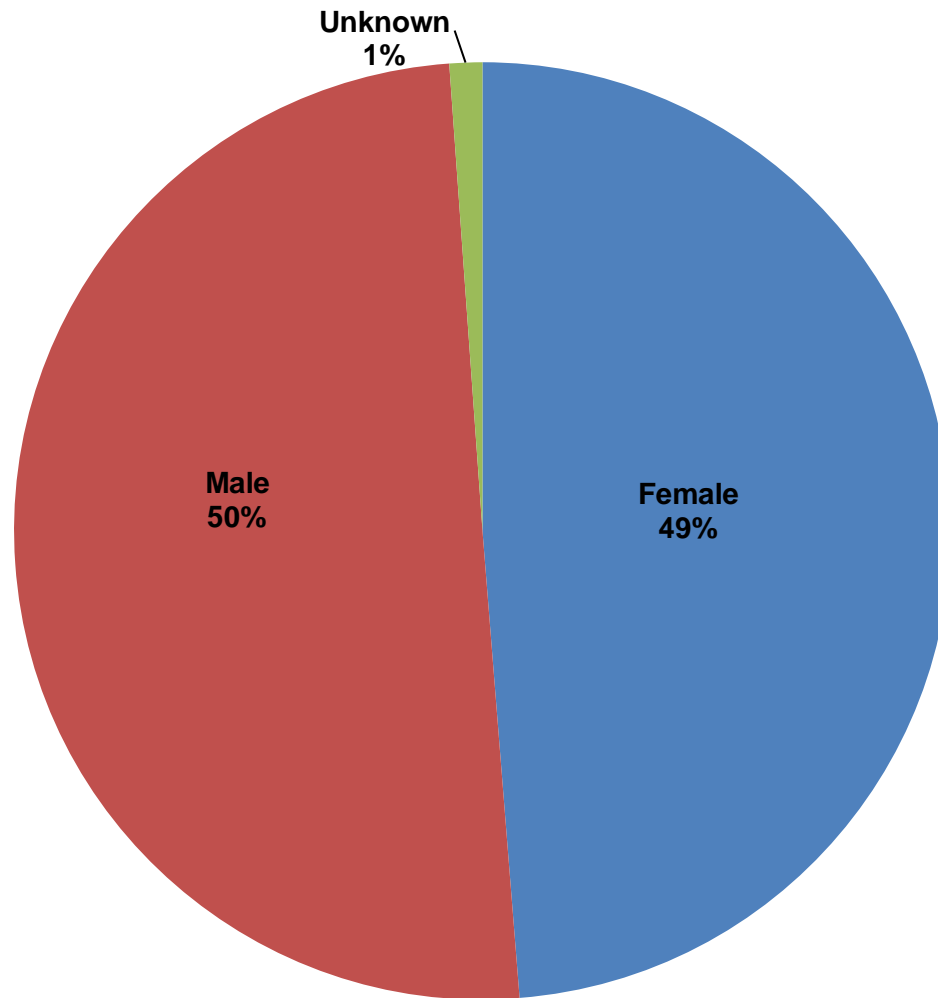

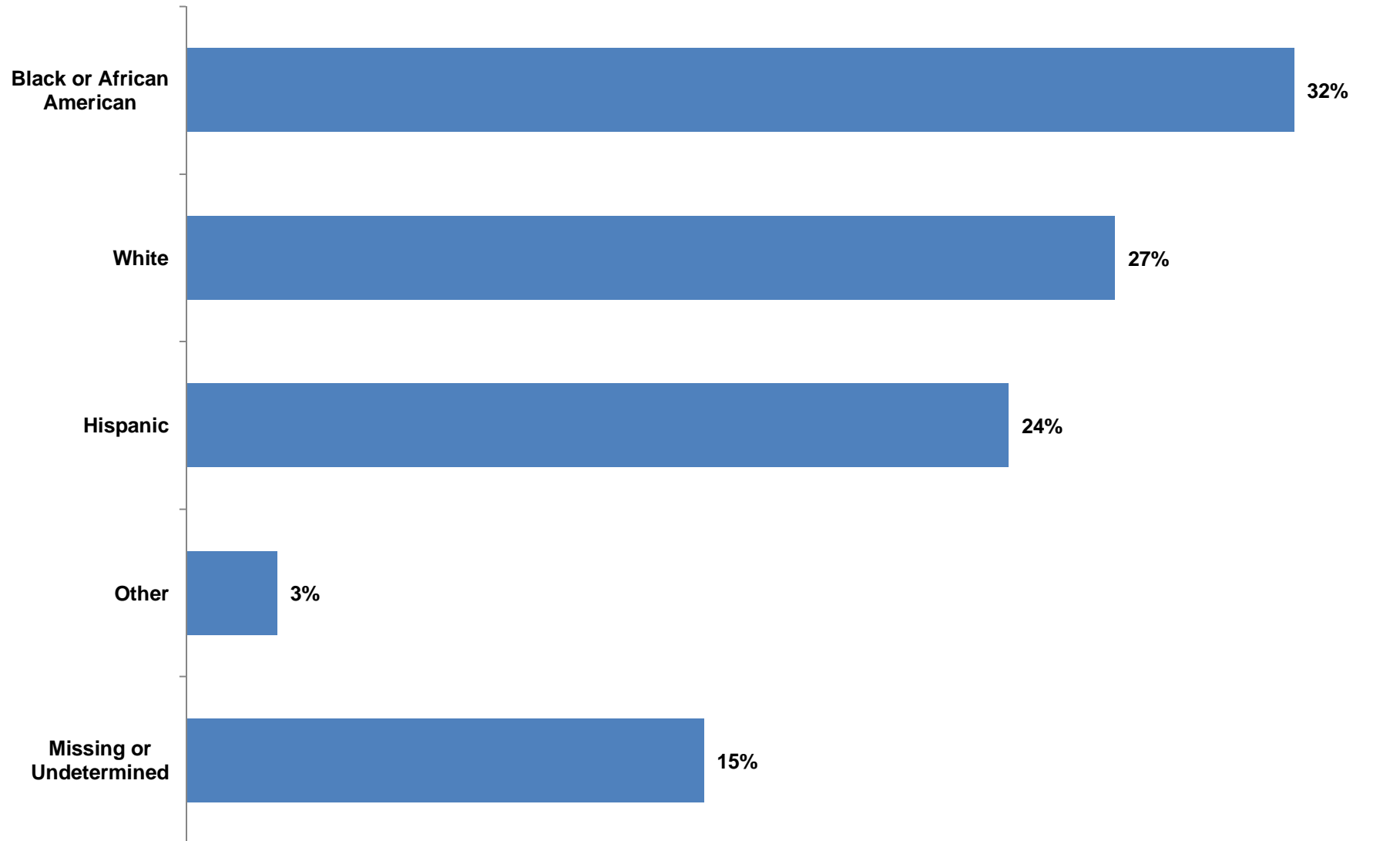

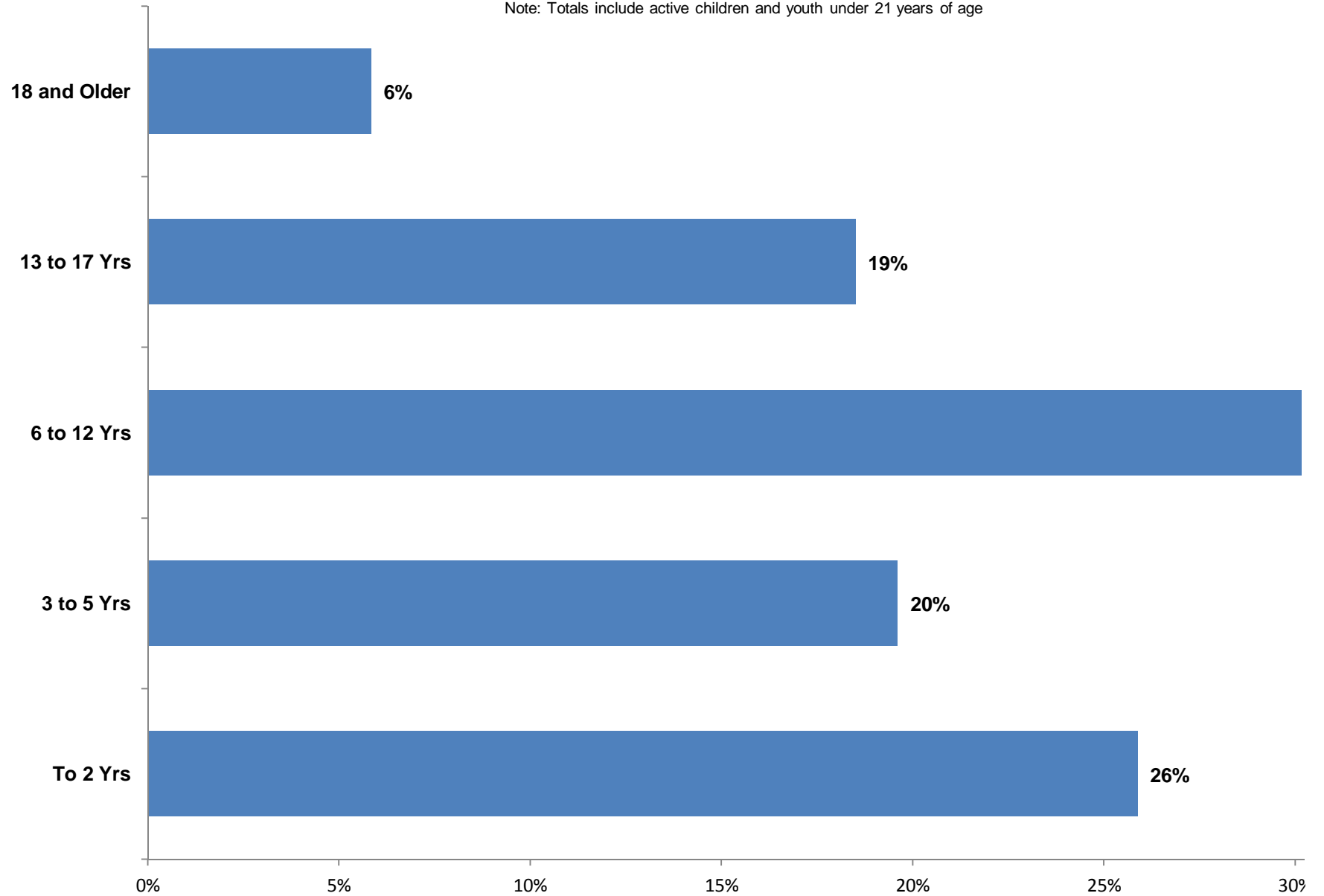

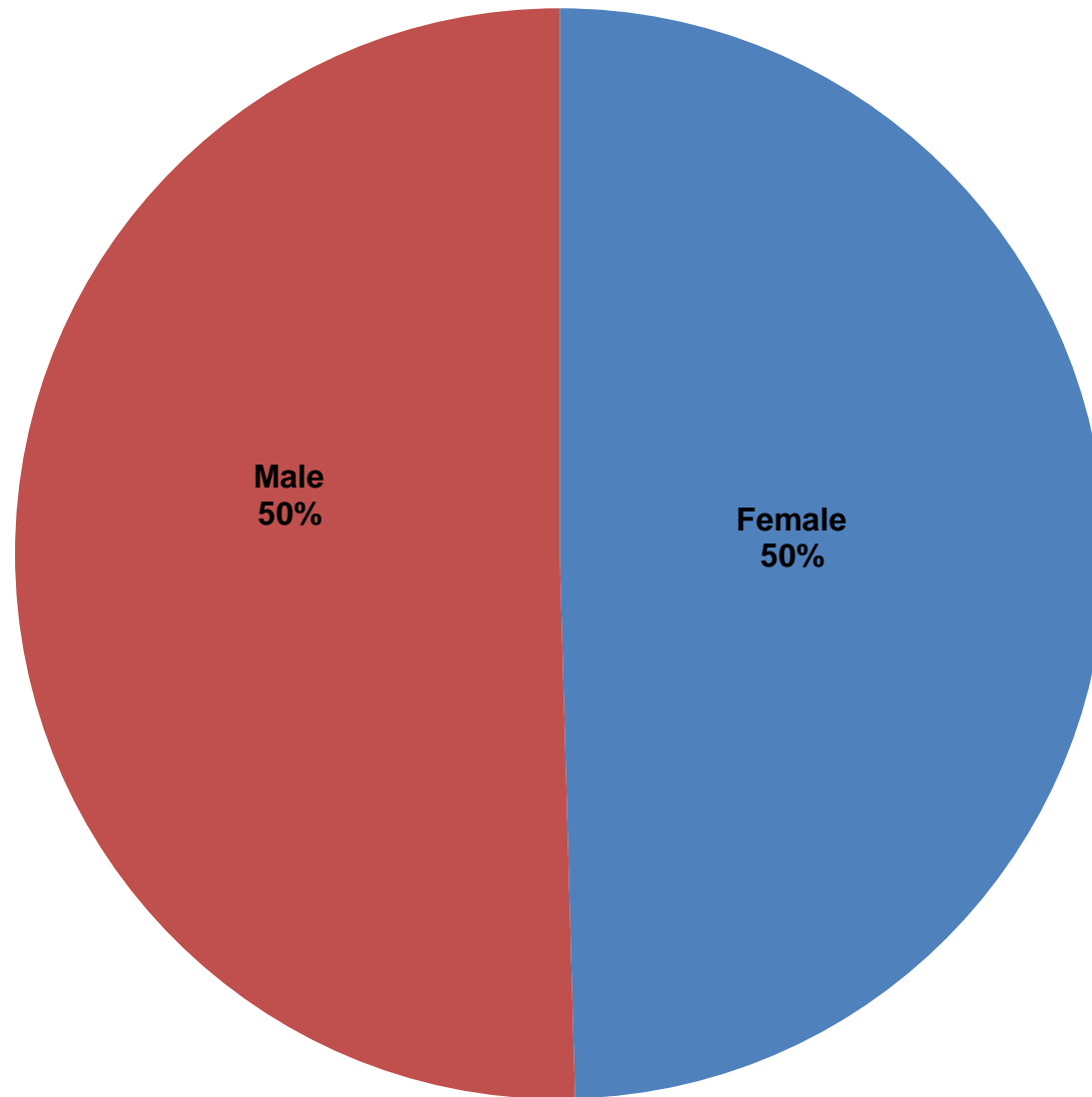




Gender of Children in CP&P Out-of-Home Placement

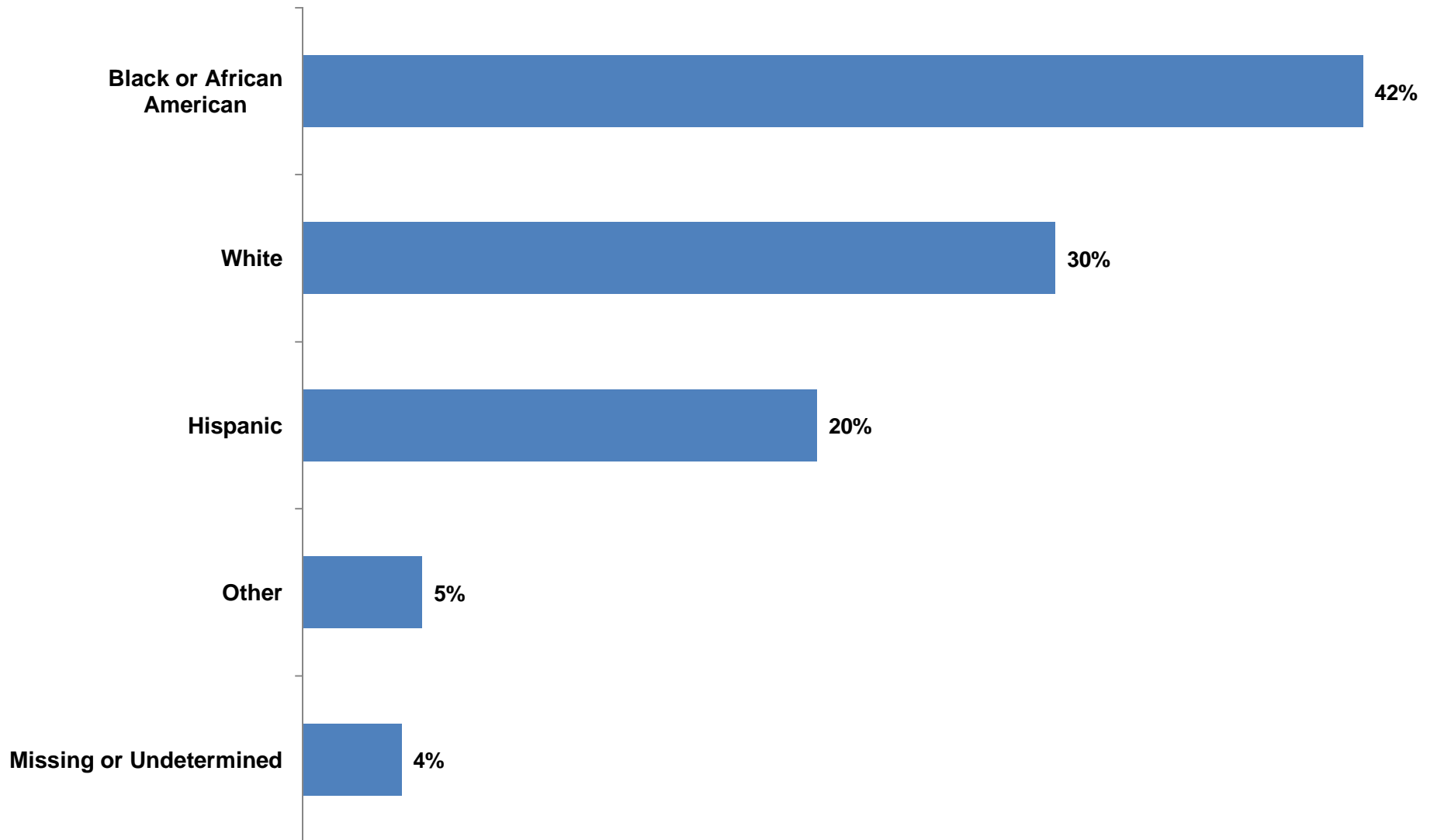




Race / Ethnicity of Children in CP&P Out-of-Home Placement

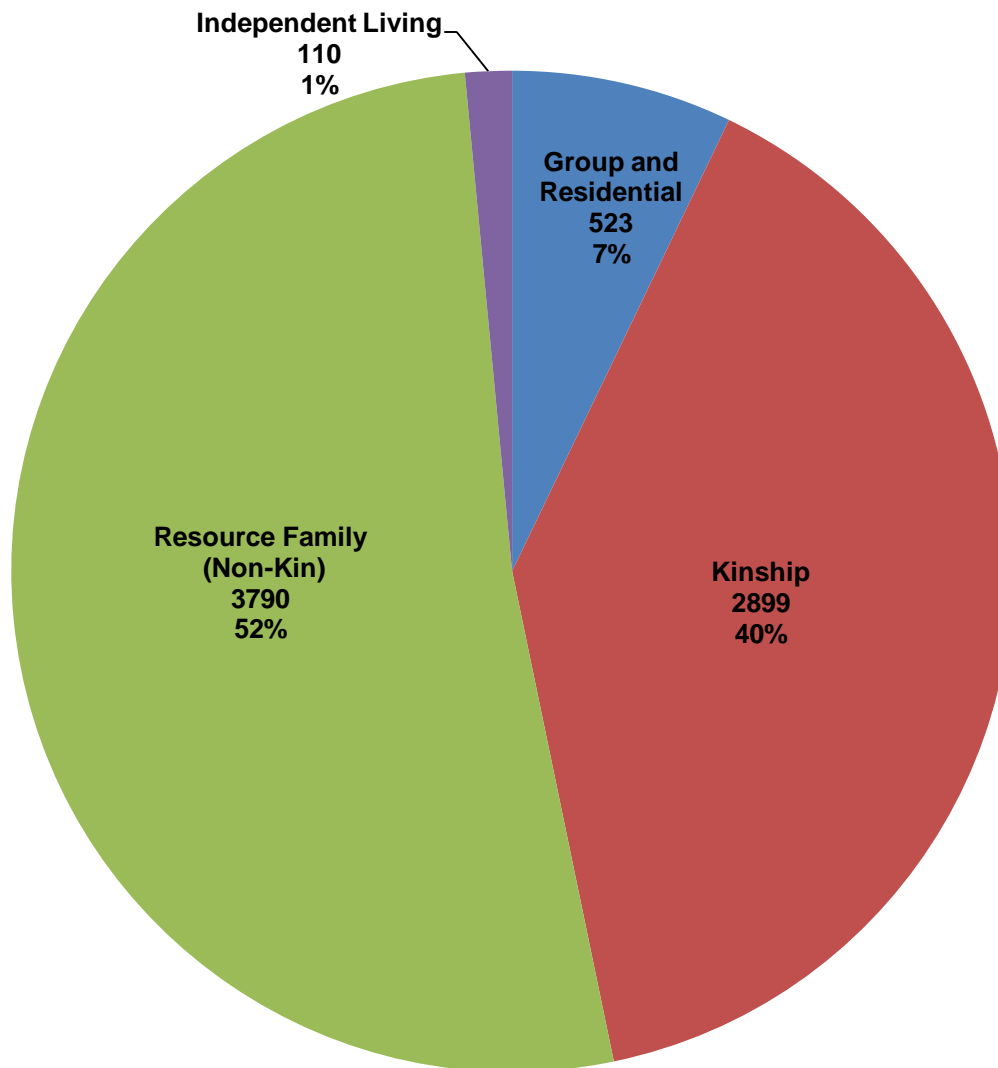
