## **Speaker Bios:**



John Giordano, Esq. - Assistant Commissioner, NJDEP, Air Quality, Energy and Sustainability: On July 6, 2015, John Giordano was appointed the first Assistant Commissioner of the Department's newly formed division of Air Quality, Energy and Sustainability. Immediately prior, John served as the Assistant Commissioner for Compliance and Enforcement, where he led the division in its mission to uphold federal and state environmental and natural resource

laws and regulations, including those related to water and air pollution; hazardous materials; solid waste; land use; biocides; water, wetland, and wildlife conservation; and environmental management.

From 2011-2013, John was Deputy Secretary for Administration at the Pennsylvania Department of Conservation and Natural Resources (DCNR). Here, John served in the Department's second-ranking position as its chief operating officer, overseeing all administrative, management, and information technology operations and business services to ensure that the Department's resources were optimally deployed at headquarters and across 8 regional offices, 120 state parks, and 20 forest districts. This included maintaining oversight of approximately 2300 full-time and seasonal personnel and a budget of \$300 million

Prior to joining DCNR, John was Executive Vice President and Chief Legal Officer of a New Jersey-based transportation and equipment leasing company, and an associate at a global law firm.

John is also a former federal prosecutor and senior Justice Department official, having served in the United States Attorney's Office for the Eastern District of Virginia, and as Counselor to the Assistant Attorney General for the Environment and Natural Resources Division at the U.S. Department of Justice. Before joining the Justice Department, John served as a Senior Advisor and Staff Director at the U.S. Department of Energy.

Association in October 2014. Michele came to NJBIA from the New Jersey Department of
