General Permit

Woodworking Equipment

This General Permit allows for the construction, installation, reconstruction, modification and operation of one or more pieces of woodworking equipment, located at the same facility, where all air contaminant emissions from the equipment are captured and vented to a particulate control apparatus with a design removal efficiency of at least 99%.

Registration under this General Permit is for woodworking equipment connected to single or multiple control devices venting to one or more common stacks.

I. DEFINITIONS

The terms used in this General Permit shall have the meanings given to them in N.J.A.C 7:27 et seq., except those noted by an asterisk (*).

***Woodworking Equipment** means any equipment used for sanding, drilling, cutting or planing, wood or wood products.

II. AUTHORITY

This General Permit is issued under the authority N.J.S.A 26:2C-9.2. This General Permit shall allow for inspection and evaluation to assure conformance with all provisions of N.J.A.C 7:27 et seq. An opportunity for public comment on this General Permit was provided on August 18, 1997.

III. APPLICABILITY

One or more pieces of woodworking equipment, located at the same facility, where all air contaminant emissions from the equipment are captured and vented to a particulate control apparatus with a minimum design removal efficiency of 99%.

NOTE: Hand held equipment and equipment used for the sole purpose of woodworking which vent solely into a room, are not required to obtain air permits as per NJAC 7:27-8.2(d)5&6.

IV. EXCLUSIONS

Surface coating sources or woodworking sources which vent through common ductwork with surface coating sources (or any other non-woodworking sources) are not eligible for this General Permit.

Woodworking equipment venting to a cyclone only is not eligible for this General Permit.

V. EQUIPMENT/CONTROL DEVICE SPECIFICATIONS

The Permittee shall retain on site the manufacturer's specifications or engineering calculations for particulate control apparatus showing a minimum design removal efficiency of 99%. Records shall be kept for the life of the control apparatus.

Particulate control devices capable of achieving such removal efficiencies include, but are not limited to, baghouses, cartridge filters, and cyclones followed by afterfilters.

The Permittee shall maintain the particulate control apparatus consistent with the manufacturer's specifications.

VI. COMPLIANCE PLAN

The Woodworking Equipment covered by this General Permit is subject to the applicable requirements listed on the following pages.

1.	<p>This equipment shall not cause any air contaminant, including an air contaminant detectable by the sense of smell, to be present in the outdoor atmosphere in such quantity and duration which is, or tends to be, injurious to human health or welfare, animal or plant life or property, or would unreasonably interfere with the enjoyment of life or property, except in areas over which the owner or operator has exclusive use or occupancy. {N.J.A.C 7:27-5}</p>	None	<p>Permittee shall record in either a permanent bound log book or in readily accessible computer memories instances (date and time) when the operation of equipment has the potential to cause off-property effects. All records must be maintained on site for a minimum of 5 years. {N.J.A.C 7:27-8.13(d)3}</p>	<p>Any operation of the equipment which may cause a release of air contaminants in a quantity or concentration which poses a potential threat to public health, welfare, or the environment or which might reasonably result in citizen complaints shall be reported by the Permittee as required by the Air Pollution Control Act. 2.	<p>Permittee shall not use the equipment in a manner which will cause visible emissions exclusive of condensed water vapor. {N.J.A.C 7:27-8.13(a)}</p>	<p>Permittee shall visually observe the stack once each month if the equipment is used for more than 2 continuous hours during the month. {N.J.A.C 7:27-8.13(d)}</p>	<p>Permittee shall record in either a permanent bound log book or in readily accessible computer memories, that the stack was observed (date and time) and if operation of the equipment causes visible emissions exclusive of condensed water vapor. All records must be maintained on site for a minimum of 5 years. {N.J.A.C 7:27-8.13(d)3}</p>	<p>If visible emissions are observed, refer to operator manual for corrective measures and record corrective action. If measures fail to correct visible emissions within 24 hours of observation, report the incident in writing to the Regional Enforcement Office within three working days. {N.J.A.C 7:27-8.13(d)4}</p>
