If submitting the report electronically, check under Electronic Reporting Guide. When submitting multiple reports, a separate fee verification form is required for each site. However, you do not have to send separate checks for multiple sites. Amount owned for separate sites may be combined into one check. *If you are not required to file a Hazardous Waste Biennial Report, this form need not be returned.*

No fee is due if this site was not a RCRA Large Quantity Generator (LQG). Refer to page iii of the instruction booklet for the definition of a RCRA LQG. Do not include non-hazardous waste in your calculations. This current fee is based on the amount of hazardous waste generated during the calendar year 2009, not the amount shipped. To calculate the amount generated, use section 1, box F on the GM form. Convert this figure to tons and calculate the total for all of your GM forms. Round to the hundredth place. For example: 85.105 tons should be rounded to 85.11 tons.
