Dear Regulated Community:

On November 17, 2003, the New Jersey Department of Environmental Protection (hereinafter "the Department") adopted new fees. In previous years, the Compliance Monitoring portion of the fee was combined with the annual renewal for a permit/approval. With this regulation adoption, the fees for the permit/approval renewal and compliance monitoring have been separated. You will now receive a minimum of two invoices from the Department for Annual Fees. For example, the annual fee for fiscal year 2010 (July 1, 2009 through June 30, 2010) will be broken down into the renewal of the permit/approval for that time period, with a separate and distinct invoice for the compliance monitoring portion covering the same time period. It states in the regulation that these fees for compliance monitoring will be issued quarterly for all solid waste facilities, beginning July 1. The compliance monitoring fees for each category are listed below:
