New Jersey Electronics Manufacturer Registration Form

Registration is required for any manufacturer of covered electronic devices (CED) offered for sale for delivery in New Jersey. A registration fee of \$5000.00 must be submitted with this registration form to the address listed above. If a manufacturer produces both televisions and other covered electronic devices, two registration fees must be paid. The fee(s) shall be paid via check or money order payable to "Treasurer, State of New Jersey." Registration fee and form shall be submitted by January 1, annually.
