2. All food vendors selected to participate must have **COMPREHENSIVE GENERAL LIABILITY INSURANCE** in the amount of **at least \$500,000.00**. Proof of Comprehensive General Liability Insurance must be submitted <u>directly from the insurance agency</u> and received by May 15, 2012. Certificates should be mailed to: Lisa Barno, NJ Division of Fish and Wildlife, 23 Reese Avenue Hackettstown, NJ 07840.

3. If your application is accepted, review the enclosed Warren County Board of Health information packet. Also review the enclosed information from the NJ Division of Fire Safety and complete and submit their Application for Permit, per their instructions. Fire Safety inspections will occur during set up times for the event.

Setup must be complete by 9:00 AM Saturday morning and exhibitors will not be permitted to breakdown before 5:00 PM on June 3, 2012. Tents and grounds must be vacated by 7:00 PM on Sunday, June 3, 2012.

IMPORTANT INFORMATION

• Event spaces are limited and will be reserved on a first-come-first-serve basis. Event spaces will be assigned by Centennial organizational Staff (food vendors – see note in above "Food Vendors" section).

- Event organizers reserve the right to reject late registrations or registrants that are not in accordance with the event's objectives. Incomplete applications may not be accepted.
- You will be **e-mailed** an event confirmation, logistical information and a parking pass before the event.
- The Centennial Celebration will be held rain or shine, so please prepare accordingly. If the forecast is particularly dire, you will be contacted 2 days prior to the event to let you know if there will be activity cancellations.
- No commercial vendor shall be permitted to remain overnight on the grounds
- All food vendors shall post in plain sight of the public any certificates issued by Division of Fire Safety to the vendor.
- No alcoholic beverages or controlled substances shall be sold, consumed or possessed on the grounds.
- Commercial vendors shall keep their assigned space(s) in a neat, clean and sanitary condition at all times by removing all debris, litter and refuse and depositing the same in containers provided for this purpose.
- Commercial vendors are encouraged to bring tablecloths or table coverings and signs identifying your organization.
- Stations shall remain adequately staffed for the entire duration of the event.
- Overnight security will be provided on the grounds for Friday, 6/1 and Saturday, 6/2. Commercial vendors shall be responsible for the safekeeping of their exhibits, displays, merchandise and supplies. Event organizers are not responsible for the loss, theft or destruction of the same.
- All commercial vendors shall assume all responsibilities for any damage resulting from the operation of their exhibit, product or service. All vendors shall understand and agree that event organizers and their agents and employees shall be held harmless from any liability arising from the use of exhibit or vending space(s). event organizers and their agents shall also not be responsible for any loss, damage or injury due to theft, fire, explosion, natural effects of the weather, vandalism, or arising out of failure of electric power or related equipment, or for any force of nature, civil commotion or disasters of any kind, or for any other condition beyond their control resulting to persons, equipment, merchandise, display or exhibitor/vendor space contents.
