Messrs. Goheen and McFarland were present. Messrs. Robinson and Stonnell were represented by an agent. Messrs. Gaine, Gates, Sacco, Toussaint and Gant were not present.

Mr. Normant reminded the Council that lease renewals begin on October 15 of each year. As per the leasing regulations, N.J.A.C. 7:25-24.8, shellfish leases must be renewed annually by December 31st for the following year. If illness or extenuating circumstances had prevented a lessee from renewing their lease(s) by December 31st, the Council may extend the payment deadline by one month provided the request was made at the January meeting. On a motion by Mr. Hughes and a second by Mr. Twist, the Council granted a 30 day extension to Messrs. Goheen, McFarland, Robinson and Stonnell to renew their leases.

9. Old Business:

Hurricane Sandy Impacts to Shellfish Industry

Mr. Normant informed the Council that the Bureau had just mailed out a questionnaire to all commercial shellfish license holders and dealers in an effort to assess damage and losses to the shellfish industry as a direct result of Hurricane Sandy. Lease Transfer - Dry Bay

Mr. Parsons informed the Council that he had attempted to contact Mr. Schriever to try and retrieve his equipment from a shellfish lease that was transferred from Mr. Joseph Brooke to Mr. Schriever. Mr. Parson's had been using the lot prior to the transfer. Mr. Johnson suggested that Mr. Parsons contact Mr. Schriever by certified mail.

Little Egg Harbor Bay Shellfish Closure

Mr. Johnson initiated discussion regarding the ongoing shellfish harvest closure of the southern part of Little Egg Harbor Bay from the effects of Hurricane Sandy. After Hurricane Sandy, water temperatures had plummeted and the clams had not been able to purge even though the water quality had returned to acceptable levels suitable to shellfish harvest. Discussions focused on the types of analysis and tests conducted to determine coli phage levels and the presence of Norwalk virus in the shellfish. The Messrs. Dale Parson and Pete McCarthy questioned the sampling methodology used to open and close waters for

shellfish harvest. Mr. Normant stated that he had talked to Mr. Schuster from the Bureau of Marine Water Monitoring (BMWM) prior to this meeting and that the BMWM was willing to set up an information / discussion meeting with the shellfishermen. Mr. Normant stated that he would contact Mr. Schuster to set up a meeting.

10. New Business:

2012 Mullica River Oyster Seed Bed Sampling

Mr. Normant stated that annual sampling on the Mullica River oyster seedbeds was completed on December 12, 2012. Mr. Normant stated that oyster bed condition had improved overall, on both the French's Point and the upper portion of the Moss Point beds. The lower portions of the Moss Point Bed still had very low bed conditions.

Little Egg Harbor Bay Shellfish Inventory

Mr. Gef Flimlin inquired on the results of the 2011 Little Egg Harbor Bay shellfish inventory. Mr. Normant stated that Mr. Celestino was not available to discuss the results since he was involved with the Delaware Bay Oyster Stock Assessment Workshop this week. Mr. Normant quickly summarized that the estimated hard clam stock did increase over the previous survey conducted in 2001, but still was below the estimated stock found in 1986/87.

Fuel Tank on Marsh in Little Egg Harbor Bay

Mr. Tim Hewitt reported that a 1,200 gallon fuel tank was on the marsh in Little Egg Harbor Bay near Thompson Creek. Mr. Hewitt has a lease near the site. Mr. Normant stated he would look into the issue.

Highlands Clam Deputation Commission

Mr. Flimlin stated that the Borough of Highlands was re-evaluating the lease to the Baymen's Protective Association which expires in 2014. Over a number of years, there had been allegations of theft of product. The Highlands Clam Depuration Commission had written a letter to the BMWM reminding them that the regulations, as written, require the depuration plant to record number of bushels as well as number of clams, however, these rules has not been enforced. Mr. Flimlin stated the Commission requested to reinstated the permit to allow depuration in Special Restricted waters and return the wording of the permit back to the May 1999 language, which stated that the clams need to counted before the clams enter the depuration plant. Commission had not received a response from the BMWM. Mr. Normant stated that he would contact the BMWM.

The meeting was adjourned on a motion by Mr. Twist and a second by Mr. Hughes.
