

1. There is one reporting form to report landings of blue crabs. Indicate by checkmark which license type (Crab Pot, Atlantic Coast Crab Dredge, Delaware Bay Crab Dredge) is being reported. Harvesting activity for one license only should be recorded on each form. Please report harvest of crabs and conchs ON CURRENT FORM ONLY.

**FAILURE TO FILE MONTHLY HARVEST REPORTS\* ON OR BEFORE THE 10<sup>TH</sup> OF THE MONTH OF RECORD WILL LEAD TO SUSPENSION OR PERMANENT REVOCATION OF YOUR COMMERCIAL CRAB LICENSE ACCORDING TO THE FOLLOWING SCHEDULE:**

1. First Offense - No suspension
2. Second Offense - 120 suspension open season days
3. Third Offense - permanent revocation

**If you did not crab during a month, a report to that effect is still required. All licenses are valid for entire calendar year.**
