

# Instructions for Statement of No Interest Applications

A Statement of No Interest is an official document issued by the State of New Jersey attesting to the fact that a particular property or area is free from all State tidelands claims.

As stated in N.J.S.A. 12:3-10 and N.J.S.A. 13:1B-13, State-owned tidelands are defined as all lands currently and formerly flowed by the mean high tide of a natural waterway. These lands are known as State tidelands claims. For example, if a property was bisected by a small tidal tributary of the Delaware River in 1920 and this tributary was filled in without a State conveyance in 1922, the area that was once occupied by that tributary is a State tidelands claim. This claim represents a cloud on the property owner's title.

A Statement of No Interest may be obtained for some properties as evidence that no such claim exists. These documents are only issued when an applicant can prove beyond all doubt that the State of New Jersey has no tidelands claim to that particular parcel.

Statement of No Interest applications will only be considered in the following circumstances:

1. The State's claim is in close proximity to the subject property.
2. The subject property is affected by a State tidelands claim according to the adopted Tidelands map, but the applicant questions the validity of that claim.

Statement of No Interest applications will not be considered in these circumstances:

1. The State's claim is not in close proximity to the subject property.
2. The subject property is affected by a State tidelands claim according to the adopted Tidelands map, but the claim has been eradicated by an existing valid conveyance such as a riparian grant. If the validity of the existing conveyance is in doubt, please submit a grant application.

Statements of No Interest often require complex processing as well as significant amounts of research. Therefore, a Statement of No Interest may take as long as two years to obtain.

The State of New Jersey is under no obligation to issue a Statement of No Interest.

## **Statement of No Interest Application Requirements\*:**

**The materials listed in Section A are required for all Statement of No Interest Applications. Some applications will have further requirements as described in Sections B – D. Please note that an application may have requirements from multiple sections.**

A. All applications must include the following:

1. **Statement of No Interest Application Form** – completed and signed by all persons listed as the current owner on the most recent recorded deed
2. **Application Support Letter** - a typed explanation providing the reason (as defined by the criteria listed above) that the subject property qualifies for a Statement of No Interest
3. **Affidavit of Title** – completed, signed by all persons listed on the current recorded deed, and notarized
4. **Recorded Deed** – a copy of the current deed as recorded in the County Clerk's office
5. **Property Survey** – four (4) copies of a survey; each copy must meet all of the following requirements:
  - signed and sealed by a New Jersey Licensed Land Surveyor or a Professional Engineer; photocopies will not be accepted
  - depicts the existing and proposed conditions of the property
  - supplies the date of the original drawing and of any revisions; the date of either the original drawing or of the most recent revision must be current
  - provides the owner's name, tax lot and block, municipality and county for the subject property
  - drawn to scale in either a 1"=10', 1"=20', 1"=30', 1"=40', 1"=50' or 1"=60' scale; other scales will not be accepted
  - provides the standard engineering scale used
  - includes a north arrow
  - depicts the complete upland of the subject property and provides appropriate bearings and distances around the entire perimeter; record title must be clearly marked
  - provides the total square footage of the property
  - shows the location of the Tidelands Claim Line and notes the source of the line
  - provides the location of the current mean high water line if applicable
  - shows the location of any existing tidelands conveyances (grants, licenses, Statements of No Interest, etc.) on the subject property if applicable

- B. For applications that are based upon accepted circumstance #2 for applying for a Statement of No Interest as described above, the following must also be provided:
1. **Extensive and incontrovertible evidence** demonstrating the error in the State's claim
- C. Applicants not applying as either private citizens or as Condominium Associations (i.e. companies, corporate entities, government agencies, counties, municipalities, etc.) must also submit the following:
1. **Organization Data Form** – only a person(s) listed on this form may sign the other forms that are associated with the application (i.e. Statement of No Interest Application Form, Affidavit of Title)
- D. When applicants are applying as a Condominium Association, the following additional requirements apply:
1. The application must include a copy of the **first two pages of the Master Deed** in addition to the recorded deeds of all individual unit owners.
  2. All required forms must be completed in the name of the Condominium Association.

**\*An application fee will be required for all Statements of No Interest prior to the commencement of application review. However, do not submit any money with the initial application. A bill will be sent from the Department of Treasury upon the application's receipt. All payments must be directed to the Department of Treasury rather than to the Bureau of Tidelands Management.**
