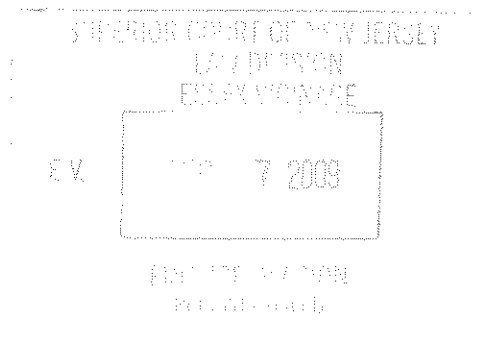

a. Response: The Third-Party Defendant Borough of East Rutherford denies it discharged hazardous substances or Pollutants at or around the site as alleged in the Third-Party Complaint(s).
