**HARRISON SUPPLY AND PHILBRO,
INC.'S INITIAL DISCLOSURE PURSUANT
TO CMO VIII**

Harrison Supply Company and Philbro, Inc. ("Harrison Supply and Philbro"), by way of its Initial Disclosure in accordance with Case Management Order V and paragraph number 3 of Case Management VIII, provides the following specific information:

RESERVATIONS

1. Harrison Supply and Philbro reserve the right to object to the production of any documents or other information on any ground, including relevance and undue burden, and to assert any applicable privilege, including the attorney-client privilege, the work product doctrine, the common interest doctrine, and any other applicable privilege or protection. These disclosures are not intended to prejudice or waive any privileges or objections Harrison Supply and Philbro may have with respect to any outstanding requests for discovery.

2. Harrison Supply and Philbro's investigation in this matter is continuing. Accordingly, it reserve the right to supplement, clarify and revise these disclosures to the extent additional information becomes available or is obtained through discovery. Further, Harrison Supply and Philbro reserve the right to amend these disclosures to the extent the claims brought by or alleged against Harrison Supply and Philbro in this litigation are amended.

3. The time period covered by the allegations in the Plaintiffs' Second Amended Complaint is quite long and encompasses at least several decades. The geographic scope of the Second Amended Complaint is also quite broad, covering the "Newark Bay Complex," which spans the "lower 17 miles of the Passaic River, Newark Bay, the lower reaches of the Hackensack River, the Arthur Kill, the Kill van Kull, and into adjacent waters and sediments." See Second Amended, ¶1. The scope of inquiry required by Plaintiffs and Third-Party Defendants is accordingly quite broad and potentially burdensome. Harrison Supply and Philbro are therefore engaged in a continuing investigation and reserve the right to supplement and modify these disclosures.

Harrison Supply and Philbro further object to the above Initial Disclosure on the grounds that the term “associated” is vague and ambiguous and susceptible to numerous interpretations. Subject to and without waiving the foregoing objections and the Reservations stated above, the individual listed below is likely to have operational and/or ownership regarding the Harrison Supply and Philbro location. Harrison Supply and Philbro reserve the right to supplement or amend their response if any other relevant non-privileged information becomes available to Harrison Supply and Philbro during the litigation.

Harrison Supply and Philbro further object to this request on the grounds that the term “associated” is vague

and ambiguous and susceptible to numerous interpretations. Subject to and without waiting the foregoing objections and the Reservations stated above, see response to Disclosure No. 7 states that its investigation is ongoing and reserve the right to identify additional witnesses at the appropriate time, and reserve the right to supplement or amend its response if any other relevant non-privileged information becomes available to Harrison Supply and Philbro during the litigation.

- c. **The name, address and telephone number, as may be known of any and all past or present owners, lessees or operators at the site(s) and/or properties with which it is associated in the Third-Party Complaint and the dates of such ownership, lease or operation, as may be known.**

Harrison Supply and Philbro object to this request on the grounds that the term “associated” is ambiguous and susceptible to numerous interpretations. Subject to and without waiver of its objection, Harrison Supply and Philbro have present knowledge as follows:

Since 1927, the property has been owned by Philbro, Inc. and Harrison Supply has been a lessee/operator in Third-Party Complaint “B”

- d. **With respect to any individual identified pursuant to paragraph (a), (b) or (c) above, (or any other individual known to have material knowledge of any alleged discharge or release of a Pollutant at or from a site and/or property, or into the Newark Bay Complex), any known inability to testify due to age, infirmity, or incompetency within 12 months following the date of the Initial Disclosure.**

Harrison Supply and Philbro further object that the term “associated” is vague and ambiguous and susceptible to numerous interpretations. Subject to and without waiving the foregoing objections and the reservations stated above, Harrison Supply and Philbro have no knowledge of any known inability of the above listed individuals to testify.

- e. **A description by category and location (or copy at the discretion of the Third-Party Defendant) of all documents or electronically stored information**



- a. Information (“Information”), including, but not limited to, environmental, chemical and/or biological testing or groundwater, surface water, soil or sediment (hereinafter “Sampling Information”) contained in the nexus packages produced pursuant to paragraph 8(e) of CMO V; and
- b. Information previously produced to any branch, department, agency or instrumentality of the State of New Jersey including to the New Jersey Department of Environmental Protection (“NJDEP”) or Information produced to any other governmental agency or entity whose responsibility it is to oversee environmental compliance in the Newark Bay Complex Area, including, but not limited to, the United States Environmental Protection Agency and the United States Army Corps of Engineers (hereinafter “Governmental Recipients”);
- c.
